Continued petition by Nicholas Bryant & Bryant Family Farms LLC for a Conditional Use Permit on an existing 15.43-acre AB-1 Ag Bus lot in the NW/NW of S36-T5N-R3E in the Town of Mineral Point to allow a poultry processing plant.

Mr. Bryant overviewed the proposal, including he does not anticipate processing at the maximum capacity.
