- 3. - 6. Reports from Board Members; Opportunity for Members of the Audience to Address the Board-O'Brien commented that LaFayette ADRC is also working on getting various brochures into Spanish. Extension may be of some help also. Nankee mentioned we should sing Happy Birthday to McManus. McManus was hoping we could see some sites start to open July 1. We must keep all public areas very clean and safe. Nankee is looking for more info from Iowa County on dates moving forward.

7. Aging & Disability Resource Center & County Aging Unit Reports-

a.) Iowa County Updates: Schroeder reading notes from Hiltbrand, ADRC Iowa again has a display of pinwheels in front of Health and Human Services Building, ADRC entrance. Each of the 74 pinwheels represent a report of elder Abuse or neglect that they received in 2019. According to the Administration for Community Living, every year an estimated 5 million, or 1 in 10 older Americans experience abuse, neglect or exploitation. Staff wore purple on June 15th to bring awareness. In the next few months, ADRC will be doing some marketing on the radio to let people know there still operating. They are finalizing plans for prevention for late summer/early fall. Hoping to hold "Stand up Move More" and "Stepping On" in person; Powerful Tools and Boost your Brain virtually. The Dementia Care Specialist and the Alzheimer's Assocaiation teamed up to host a "Monday Coffee Connect" which is a virtual caregiver support group from 10am-

11am on Mondays starting May 28th.

- **b.)Lafayette County Updates:** Robert Schroeder, Manager for Lafayette ADRC County office, stated the doors are still closed, but they working via phone and virual. As of June 1^{st,} people are back to the office on alternating days. The programs are all doing well. The Lafayette dairy breakfast will be a drive thru operation with malts, cheese & yogurt. The Lafayette Fair is still on June 15th to the 19th they'll be following thigh guidelines.
