1	Call to order. Chair, Vickie Stangel called the meeting to order at 10:06 AM.	
2	Roll Call: Members Present: Vickie Stangel, Diane Palzkill, Beverly Harris, Carol Anderson, Linda Gard Absent: Alex Ray, Sharilyn Sailing, Others present: County Administrator, Larry Bierke, Kristin Mitchell of Kristin Mitchell Designs, Brittany Mainwaring of Aging, Disabilities and Resource Center	
3	Approval of Agenda: Linda Gard, moved. Carol Anderson, seconded. Motion carried.	
4	Approval of Minutes from 11/18/2019: Anderson moved, Gard seconded. Motion carried.	
5	Reports from Committee Members: No reports from committees.	
6	Kristin Mitchell reported on Iowa County Library Logo design. Motion was made following discussion by Anderson, and seconded by Harris to adopt circle logo with green background behind open book. Motion carried. Mitchell suggested refreshing logo in 3 to 6 years. She stated it is important to look at the next steps ie. Business cards for individual libraries, book marks with hours, magnets, rack cards, patches, etc. Harris suggested links on each of the library websites which would open to the other libraries in Iowa County with their hours. An Iowa County Libraries Facebook page is an option.	
7	Anderson asked for monies available the Iowa County Library Comm. Bierke gave the amount as \$11,190.00. Anderson suggested using \$5,000 for advertising projects and \$5,000 for grants. She and Birke will work up grant applications with possible matching funds. Bierke spoke to the importance of contacting local governments and Library Boards to inform them of what the Iowa County Library Committee is doing with logo, grants, etc.	
8	Brittany Mainwaring from ADRC presented the Iowa County Hub which is in place under Iowa County Government. Libraries are listed under several categories. She asked that this site be put on the Iowa County Library computers. The site has been developed to pass information from the HEART organization along with News and Views to the elderly and disabled. Birke asked if it was possible to insert the logo, but it was thought not. Stangel spoke of 11 HEART benches going into area communities and Senior Citizen signage for events like the Iowa County Fair and Dairy Days as a result of collaboration of libraries, and surveys. Stangel suggested placing News and Views in plastic sleeves in libraries. Bierke said monitors are available in the Health and Human Resources Center for non-profit events to be listed. Mainwaring spoke of the importance of getting the word of events out, but they need to be submitted two months in advance. Gianna is the IT link person for adding info to site.
