Some of the featured activities could be ATV's, hiking, canoeing, fishing, etc.

Currently the guide notes, "Here we are, here is what you can do." Abby's suggestion would reverse that thinking to "here is what you can do, and here is where you can do it." There was further discussion but no action was taken at this time. This will be revisited on upcoming agendas.
