both groups. Motion by Ladewig to name it the ADRC Care A Van. Seconded by Meek. Motion carried. **Bus Schedule Advise** – Daentl and Mumm shared a document and presented a sample bus schedule. The bus will be used three days a week. One day would always be a Dodgeville/Mineral Point shuttle day. The other two days would change and go to different communities in Wisconsin. The Rural Taxi ridership is growing but is limited by the size of the taxi (only one person at a time unless they are family members). Rolfsmeyer asked if customers do their grocery shopping with us or if we do the grocery delivery to them. Ladewig said it would be sad to see the bus and taxi only being used as a grocery delivery service. Daentl said customers use it for a multitude of reasons: appointments, prescription pickup, meet friends for lunch, shopping, laundry, etc. The discussion turned to the rumor that Mineral Point might Transportation lose their grocery store, if so; more customers from Mineral Point would need transportation to a grocery store. Daentl said there are only a few stores that let customer's pre-order/pre-pay for their groceries. Our taxi driver does not shop for them. Nankee asked if the new bus would have a better suspension than the old bus. Daentl is unsure, as she doesn't design them. Ladewig felt Daentl and Mumm would know what is best in the design of the schedule. Mumm asked if they felt a shuttle service one day a week would work. Ladewig said if it is marketed well, it should be ok. Ladewig said we aren't going to micro-manage you, if things aren't working, come back to us. Ladewig asked if the bus could attend events, such as 4th of July. Daentl replied that it would depend on many things such as the hours of the hired bus driver, if it were a weekend or weekday, if our building is open or closed. **April report and 2020 year in review** – Cathy Palzkill is a new approved driver escort volunteer. We will be getting the new bus in the next day or so. Palzkill thinks the taxi numbers are fantastic. It's great to see the ADRC Taxi is very busy. 15) **Recognition of Board Members**: Valerie Hiltbrand presented Both Palzkill and Rock have been on the Board since 2015. Thanked them for their guidance and advocacy. Can still be involved even if you aren't a voting member of board. Presented with a certificate. (applause) ADRC Manager **ADRC Manager's Report:** HHS Center reopened on May 1st. Options to meet on phone or zoom too. Encourage consumers to make appointments. Senior Farmers Market Vouchers. Receiving 113 this year beginning June 1. This year we will be doing outreach at distribution sites. Support our local farmers and economy. Stand Up and Move More is going well. Mind Over Matter: Healthy Bowels, Healthy Bladder is a virtual class. Easy class to fill in other counties. Common issue and there is something we can do about it. Educational workshop. Meets only three times. Not a huge commitment of time. McManus mentioned nutrition education. Mainwaring is being trained in

Stepping Up Your Nutrition. Can then get people involved in other prevention

programs. Correlation between nutrition and falls.

| | McManus partnership with HeART Coalition – Bruce Paull is employed to do annual assessments of delivery participants and then he will make sure people know about the ADRC and check on home modifications. Habitat for Humanity is also involved. Can then make referrals to the ADRC. Events – May is Older Americans Act Month and ADRC Month. June is Elder Abuse Awareness Month. Pinwheels again outside the ADRC. Parking Lot Bingo on June 15. June is Brain Health Awareness Month. New DCS (Dementia Care Specialist) has a great brain health campaign planned. Advocacy Updates: Aging Advocacy Day. O'Brien attended. There were people who had never attended before and were able to attend because it was virtual. Discussed ADRC Reinvestment, Family Caregiver Support, Lowering Healthcare Costs, and Infrastructure Expansion. Questions – Ladewig asked if there are brochures being distributed that describe or give examples of elder abuse. Hiltbrand said there are and she will make sure she has more to distribute. I-Team (Elder Abuse Interdisciplinary Team) meets quarterly to collaborate on elder abuse cases. Ladewig suggested warning signs be distributed to home meal delivery participants. O'Brien brought up again using something else instead of cute pinwheels to call attention to elder abuse. Hiltbrand replied we have been looking for something different but based on timing and expenses, haven't found the right item. Oleson mentioned the reason they were chosen is that they are so eye-catching. People do stop and read the signage. Hiltbrand said many ADRCs in | |
