O	Bierke has contacted 3 different companies regarding survey creation, but has only heard back from the
	U.W. Center for Community and Non-Profit Studies. It could cost between \$10,000.00 and \$15,000.00.
	Hottman shared information gathered from his colleagues throughout the State. The suggestions included
	utilizing focus groups instead of surveys, thinking of the new facility as a public service issue not a building
	or tax issue, determine the quality now and what it might be in the future, and visionary planning that
	transitions into scenario planning. Anderson suggested utilizing the ADRC Board and Bloomfield Staff with
	the focus group as well as the use of electronic surveys in addition to paper surveys. The committee should
	determine four or five goals to reach with focus group and survey information. Paull shared information
