***NOTE THE FOLLOWING ARE THE MEETING PROCEDURES USED BY THE BOARD OF ADJUSTMENTS:**

- a) All items are generally considered as they appear on the agenda. As each item is introduced.
 - b) Staff will present its findings and recommendation on the item being considered.
 - c) The party making the request may make a presentation and may address the Board on any issues arising during the discussion of the item being considered.
 - d) Anyone in the audience desiring to speak in favor or in opposition may do so. A 3 – 5-minute time limit will be given to each person interested in speaking on the item. The use of a spokesperson for large groups of people will be required.
 - e) Once the Chair closes the public hearing, the board may question anyone and maintain any discussion which clarifies the proposal and will then take what action it believes to be appropriate.
 - f) A minimum of four votes are required for an item to be approved by the Board.
- 6. Open public hearing/ discussion and appropriate action**
- a) Variance request by Alberto Chapa not to provide paving improvements to a 25-foot dedicated private road along the west side of the proposed 3 lot Chapa Penitas Subdivision. **(Tabled March 23, 2023)**

- b) Variance request by Alberto Chapa not to provide streetlights along the private road on the proposed 3 lot Chapa Penitas Subdivision. **(Tabled March 23, 2023)**
- c) Variance request by Alberto Chapa not to provide side walks along the private road or along US Expressway 83 on the proposed 3 lot Chapa Penitas Subdivision. **(Tabled March 23, 2023)**
- d) Variance request by Alberto Chapa not to provide fire hydrants along private road on the proposed 3 lot Chapa Penitas Subdivision. **(Tabled March 23, 2023)**
- e) Variance request by Alberto Chapa to connect to OSSF system instead of sewer connection along private road for the proposed 3 lot Chapa Penitas Subdivision. **(Tabled March 23, 2023)**


