- a) All items are generally considered as they appear on the agenda. As each item is introduced.
 - b) Staff will present its findings and recommendation on the item being considered.
 - c) The party making the request may make a presentation and may address the Board on any issues arising during the discussion of the item being considered.
 - d) Anyone in the audience desiring to speak in favor or in opposition may do so. A 3 – 5-minute time limit will be given to each person interested in speaking on the item. The use of a spokesperson for large groups of people will be required.
 - e) Once the Chair closes the public hearing, the board may question anyone and maintain any discussion which clarifies the proposal and will then take what action it believes to be appropriate.
 - f) A minimum of four votes are required for an item to be approved by the Board.


