

DECLARATION OF LOCAL DISASTER
BY
PROCLAMATION OF THE MAYOR OF THE CITY OF PENITAS

WHEREAS, due to potential inclement weather caused by Tropical Storm/ Potential Hurricane Harvey presents an imminent threat of widespread or severe damage, injury, or loss of life and property resulting from a significant weather event and other public calamity resulting there from, which requires emergency action; and,

WHEREAS, the Mayor of the City of Penitas has determined that extraordinary measures must be taken to prevent and to alleviate the suffering of people and to protect or rehabilitate property; and,

WHEREAS, the City of Penitas Emergency Management Plan should be activated;

NOW THEREFORE, I, PRESIDING OFFICER OF THE CITY COUNCIL OF THE CITY OF PENITAS, HEREBY PROCLAIM AND DECLARE:

SECTION 1. That a state of disaster is declared for the City of Penitas.

SECTION 2. That this declaration of local disaster shall be in effect for seven days from this date unless earlier terminated.

SECTION 3. That this declaration activates the recovery and rehabilitation aspects of all applicable local or interjurisdictional emergency management plans and authorizes the furnishing of all aid and assistance as deemed necessary or desirable by those administering such plans, and activates the preparedness and response aspects of such plans as provided therein.

SECTION 4. That this declaration shall be filed promptly with the City Secretary, and shall be given prompt and general publicity.

SECTION 5. That this proclamation shall take effect immediately from and after its issuance.
