Whereas, the Jefferson County Board of Legislators recognizes the importance of setting clear, ambitious priorities to guide the work of its standing committees and ensure effective service delivery and resource management, and

Whereas, the Finance and Rules Committee has reviewed and recommended its priorities for 2025 to provide a strategic focus for its efforts while allowing flexibility to address emerging issues, and

Now, Therefore, Be It Resolved, that the Jefferson County Board of Legislators hereby adopts the following 2025 strategic priorities for the Finance and Rules Committee:

1. **Purchasing and Auditing Policies:** Revisit purchasing and auditing policies to allow for the integration of credit cards and improve efficiency.
2. **Union Negotiations:** Settle ongoing union negotiations to promote stability and collaborative relationship.
3. **Election Polling Places:** Explore options to enhance accessibility of election polling places throughout the County.
4. **Employee Support Programs:** Implement an employee appreciation program and an employee assistance program to support workforce morale and well-being.
5. **Capital Plan:** Develop a more formal six-year capital plan, including a detailed fleet management plan.
6. **Budget and Audit Updates:** Provide regular updates on budget performance and audit results to ensure transparency and accountability.
7. **Bed Tax Fund Management:** Develop a plan for the bed tax fund balance and revisit the 1986 bed tax local law to align with current needs and goals.
8. **Economic Development Engagement:** Increase engagement on economic development initiatives, including developing a plan for the County's economic development fund.
9. **Health Insurance Consultant:** Hire a new health insurance consultant and issue a Request for Proposals (RFP) for a provider.
10. **Legislative Advocacy Plan:** Develop a New York State legislative agenda and advocacy plan, including an organized visit to Albany to address County priorities.
11. **Cyber Security Enhancements:** Improve the County's cyber security posture through the adoption of two-factor authentication and related measures.

Whereas, Said shared services partnership has been successful, and has expired as of December 31, 2024, and

Whereas, Both parties recommend continuing the arrangement, and

Whereas, The Town will compensate the County on the basis of \$21.48 per parcel of Town assessment roll properties for the first year of such agreement, and

Whereas, The joint services agreement will be for a period of two years, from January 1, 2025 through December 31, 2027, subject to extension for two additional three-year periods upon written agreement of the parties.

5. **Blight and Vacant Property Mitigation:** Pursue initiatives to eliminate blight and address vacant properties, including revisiting the County's role in condemnation and the management of unsafe structures.
6. **9-1-1 Tower Lease Policy:** Develop a comprehensive lease policy for 9-1-1 communication towers to optimize their use and management.

Whereas, By Resolution 292 of 2022 the County adopted the Jefferson County Coordinated Transportation Plan which describes development and implementation of a County wide public transportation system in coordination with the City of Watertown's CitiBus system, and

Whereas, Pursuant to Section 5311, Title 49 United States Code, Jefferson County will submit a grant request for funds, to include both operating and capital projects, to the New York State Department of Transportation for a project to provide mass rural public transportation service, via a third party provider for the 2024 and 2025 fiscal years, and

Whereas, Jefferson County and the State of New York have entered into continuing agreements which authorize the undertaking of the Project and reimbursement of the Federal and applicable State shares, and

Whereas, Jefferson County recognizes that the 5311 public transportation grant is a reimbursable program where the County is responsible for the local share, and that eligible federal and state funds will only be reimbursed after the County purchases the service/product and supplies the appropriate reimbursable documentation to the State Department of Transportation, and

Whereas, By Resolution 244 of 2024, Jefferson County has committed the required 10% local share for 5311 funds, and

Whereas, The County issued a Request for Proposals to identify qualified vendors to provide mobility management services for a 24-month period with three, one-year options to extend the contract. The contract term will be from June 1, 2023 to May 30, 2025 and is subject to Federal Transit Administration's Section 5311 funding, and

Whereas, Through the RFP process, the Volunteer Transportation Center was identified as a firm with the required credentials, expertise, and experience to assist the County with mobility management services for a fee not to exceed \$215,015 for initial two-year period, and

Whereas, Jefferson County will issue a Request For Proposal for resources to contract with a Third Party Operator to provide county-wide public transportation services within Jefferson County, for fiscal years 2024 and 2025, with the option of three one year contract extensions.
