Assigned funds are capital project funds that are used to cover capital improvement costs and debt service payments. Mayor and Council is authorized to appropriate this fund balance. Restricted fund balances have constraints placed on the use of resources that are either (a) externally imposed by creditors, grantors, contributors, or laws or regulations of other governments or (b) imposed by law through constitutional provisions.
