# Jury Service in Bonner County

- Jury service in Bonner County is once every 2 years OR summoned for Federal Jury Service
- Random selection based off of your Idaho Driver's license AND/OR voter registration
- Jurors are assigned by region based off of the juror's mailing address.





# Juror Summons

- Each juror that is pooled will receive a summons.
  - Questionnaire needs to be submitted within 10 days of receipt
  - Juror Stub – **IMPORTANT THAT YOU KEEP!!!**

# Juror Pay

- Juror Pay Rates
    - \$5.00 per ½ day
    - \$10.00 per full day
    - \$50.00 per day (Days 6 and more)
    - 70 cents per mile roundtrip from residence to courthouse
  - Juror pay may take a week up to 30 days to be inputted, processed, and mailed

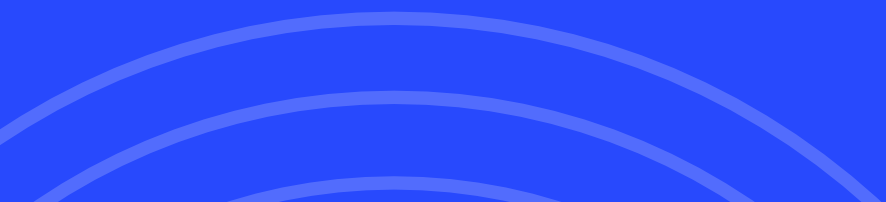
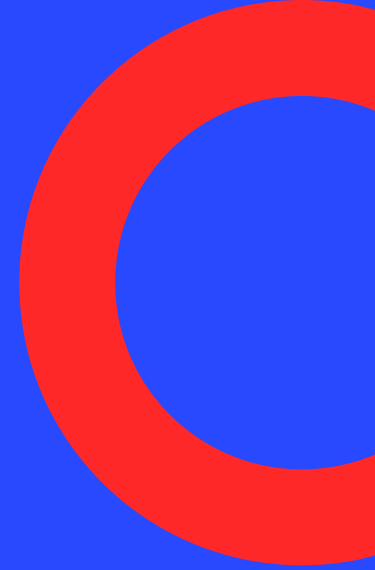
