MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

November 4, 2025 – 9:00 AM Bonner County Administration Building 1500 Highway 2, Room 338, Sandpoint, ID

On Tuesday, November 4, 2025, the Bonner County Commissioners met for their regularly scheduled meeting. Commissioners Domke, Williams, and Korn were present. Commissioner Domke called the meeting to order at 9:00 a.m. The Invocation was presented by Janine Shepard and the Pledge of Allegiance followed.

ADOPT THE ORDER OF AGENDA AS PRESENTED

- 1) Action Item: Discussion/Decision Regarding Purchase of Bits; \$45,432 Commissioner Korn made a motion to approve the purchase of the plow and grader bits from EB Blades for the sum of \$45,432.00. Funds coming from budget Line 002-7080 Bits. Commissioner Williams seconded the motion. Roll Call Vote: Commissioner Domke Yes; Commissioner Williams Yes; Commissioner Korn Yes. The motion carries.
- 2) Action Item: Discussion/Decision Regarding Purchase of Sanders; \$44,700 Commissioner Williams made a motion to approve the purchase of two (2) custom-built sanders from Steve Peck Fabrication, LLC for the total combined sum of \$44,700.00. SOLID WASTE – Bob Howard

1) Action Item: Discussion/Decision Regarding Acceptance of Pacific Steel & Recycling Metal Waste Contract

Commissioner Korn made a motion to approve that the County approve the contract for Pacific Steel and Recycling for the removal of metal piles at Dickensheet, Colburn, and Idaho Hill for the 2025-2026 fiscal year. Pacific Steel and Recycling will pay Bonner County \$101.00 per ton. Commissioner Williams seconded the motion. Roll Call Vote: Commissioner Domke – Yes; Commissioner Williams – Yes; Commissioner Korn – Yes. The motion carries.

 Action Item: Discussion/Decision Regarding Acceptance of GrayMar Household Hazardous Waste Contract

The contract will allow for GrayMar to collect, package, transport, and dispose of Bonner County residential household hazardous waste from October 1, 2025 through September 30, 2026. Commissioner Korn and made a motion to approve that the County approve the contract for Wood Solutions LLC for the removal of wood piles at Dickensheet, Colburn, and Idaho Hill for the 2025-2026 fiscal year. Wood Solutions will charge Bonner County \$49.50 per ton. Commissioner Williams seconded the motion. Roll Call Vote: Commissioner Korn – Yes; Commissioner Domke – Yes; Commissioner Williams – Yes. The motion carries.

- 4) Action Item: Discussion/Decision Regarding Budget Carryover FY2025 to FY2026; **Resolution** Commissioner Williams made a motion to approve Resolution, number to be assigned, authorizing the Clerk to open the Solid Waste FY2026 budget and carry forward Fiscal 2025 funds totaling \$16,000.00 to Bonner County Solid Waste Capital Construction fund 023-9480. Commissioner Korn seconded the motion. Roll Call Vote: Commissioner Domke Yes; Commissioner Williams Yes; Commissioner Korn Yes. The motion carries.
- Action Item: Discussion/Decision Regarding Budget Carryover FY2025 to FY2026; **Resolution** Commissioner Korn made a motion to approve Resolution, number to be assigned, authorizing the Clerk to open the Solid Waste FY2026 budget and carry forward from FY2025 funds: \$500,000 from 023-9480 Capital Improvements, \$390,000 from 023-9470 Land Improvements, and \$60,000.00 from 023-7530. Commissioner Williams seconded the motion. Roll Call Vote: Commissioner Williams Yes; Commissioner Korn Yes; Commissioner Domke Yes. The motion carries.
- 6) Action Item: Discussion/Decision Regarding Establishing Solid Waste Fees; **Resolution** There was discussion among the board and SW Director regarding the fees as presented. Commissioner Williams made a motion that Bonner County approve the Resolution, number to be assigned, to establish the disposal fees effective December 1, 2025 with the noted typographical changes as presented regarding the extra Solid Waste stickers and with confirmation from Solid Waste that the Board of Commissioners did not identify Household Hazardous Waste at no charge up to 10 gallons per event versus no charge up to 10 gallons per event with Solid Waste sticker; to include the wood brush typographical error as well. Commissioner Korn seconded the motion. There was additional discussion among the board. Roll Call Vote: Commissioner Korn Yes; Commissioner Domke Yes; Commissioner Williams Yes. The motion carries.
