Groundwater Source Protection Technical Committee Update:

Commissioner Hidden provided an update on the subcommittee on behalf of Jack Howard.

The Commission reviewed the progress they have made in prior Planning Meetings in regard to the creation of a Ground Water Source Protection Technical Subcommittee.

The Commission emphasized the importance of the Ground Water Subcommittee having no biased preconceived notions or agendas when gathering facts or developing conclusions.

The Commission discussed potential sources of data and areas of interest for the Subcommittee.

The Commission agreed that it would be premature at this point for the ground water protection language to be included in the BCRC code.

Review of the Glossary of Terms:

The Commission reviewed The Comprehensive Plan Glossary Terms provided by the Bonner County Commissioners.

The Commission agreed to individually review the Glossary and make individual annotations to be reviewed at a later date.

Review of Title 12, Chapters 3 & 4:

The Commission reviewed the following Title 12 Chapter 3 sections:

- -12-310 (Adjusted Verbiage, requested a readily available Zoning District Map showing recent zone changes)

The Commission discussed possible avenues of approach for providing the public a readily available Zoning District Map. Commissioner Bowman suggested the Planning Department always display a physical Zoning Map which would be available to the public.

The Commission explored potential issues with displaying a physical map, such as frequency of updating the map as individual parcel zoning can change.

The Commission expressed interest with eventually providing the public with a digital GIS map showing recent zoning changes, as it would be a useful visual aid.

The Commission stated this map could also be available to the public in a physical print out form if requested individually.
