Budget Transfer from Salaries "A" to Current Expenses "B"

WHEREAS, Idaho Code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted, provided that there shall be no increase in anticipated property taxes; and,

WHEREAS, the Bonner County Sheriff's Office Dispatch has positions currently not filled in the "A" Budget, allowing for an overage, and;

WHEREAS, this overage can be used to cover half of the One-Time Equipment Incentive Credit offer from Verizon Wireless.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Bonner County authorizes the Clerk to open the Sheriff Dispatch "B" budget and increase line item 00822-8590 Dispatch Equipment by \$17,522.22 and reduce line 00822-6020 by \$17,522.22.
