**Budget Transfer from Salaries "A" to Current Expenses "B"**

**WHEREAS**, Idaho Code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted, provided that there shall be no increase in anticipated property taxes; and,

**WHEREAS**, the Bonner County Sheriff's Office has positions currently not filled in the "A" Budget, allowing for an overage, and;

**WHEREAS**, this overage can be used to cover half of the One-Time Equipment Incentive Credit offer from Verizon Wireless.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Commissioners of Bonner County authorizes the Clerk to open the Sheriff "B" budget and increase line item 03453-8590 Sheriff Patrol Equipment by \$17,522.22 and reduce line 03472-6020 by \$17,522.22.

**ADOPTED** as a Resolution of the Board of Commissioners of Bonner County upon a majority vote on the 30 day of July, 25


