#### REALLOCATION OF SOLID WASTE DISPOSAL FUND APPROPRIATIONS

**WHEREAS**, Idaho Code 31-1605 authorizes the Board of County Commissioners to adjust the adopted budget, provided that such changes are supported by equal and ofseeting appropriations; and

WHEREAS, during the preparation fo the Fiscal Year 2025 budget, it was anticipated that the Colburn tipping floor asphalt would require replacement, and \$500,000.00 was accordingly budgeted under line item 023-9470 (Capital Land Improvements); and

**WHEREAS**, upon further evaluation, it was determined that the tipping floor asphalt does not require replacement; and

**WHEREAS**, Solid Waste now requests that some of the previously budgeted funds be reallocated to beter serve needs by transferring \$100,000.00 from line itme 023-9470 Capital Land Improvements to the following accounts \$60,000.00 023-7530 Site Repairs and Maintenance, \$38,000.00 to 023-7040 Vehicle Maintenance and Repairs and \$2000.00 to 023-7423 Tipping Floor Maintenance and Repairs.

**NOW, THEREFORE, BE IT RESOLVED**, that the Bonner County Board of Commissioners hereby authorizes the County Clerk to open the Fiscal Year 2025 budget and reallocate \$500,000.00 from account 023-9470 to account 023-9370 as outlined above.

**ADOPTED**, as a Resolution of the Board of Commissioners of Bonner County upon which a majority vote was had on the 12<sup>th</sup> day of August 2025.
