- 3. Sara Smith, Public Works Engineering Technician, is here for approval for the 2025 Reach the Beach Road Event Permit and the 2025 Vernonia Marathon Road Event. The indemnity agreement will be returned to the consent agenda.

Commissioner Magruder moved to approve the permit for the Reach the Beach Road Event conditionally, with Mike Russell to sign. Commissioner Garrett seconded. **Vote:** KJS/MM/CG in favor. Motion approved.

Commissioner Garrett moved to approve the permit for the Vernonia Marathon Road Event and have Mike Russell sign. Commissioner Magruder seconded. The motion carried unanimously. **Vote:** KJS/MM/CG in favor. Motion approved.

Commissioner Garrett is requesting a Letter of Support for HB 2410 and the use of our logo. After the discussion, Commissioner Magruder moved to approve the letter of support and the use of our logo. Commissioner Garrett seconded. **Vote:** KJS/MM/CG in favor. Motion approved.

With nothing further to come before this Board, the meeting adjourned at 11:00 AM.




