 - a. Ed McGlone, Assistant Senior County Counsel, read the 1st reading of Ordinance 2025-3 by title only.

DISCUSSION ITEMS

- 1. Carrie Garcia, Human Resources Director:
 - a) Request to Reclassify the Community Justice Director Position into Salary Grade E08.
 - a. Commissioner Magruder moved to approve the reclassification of the Community Justice Director Position into Salary Grade E08. Commissioner Smith seconded. **VOTE:** KJS/MM all in favor. Motion approved.
 - b) Request to Reclassify the HR Technician to an Administrative Assistant I Position.
 - a. Commissioner Magruder moved to approve the reclassification of the HR Technician to an Administrative Assistant I Position. Commissioner Smith seconded. **VOTE:** KJS/MM all in favor. Motion approved.
- 2. Grant DeJongh, Public Works Assistant Director:
 - a) Proposed Contract C93-2025, Rock Crushing Services in Ross Pit. This would allow us to maintain the road with crushed aggregate rock material at a substantial saving over buying commercially. This is usually done biennially.
 - a. After discussion, Commissioner Magruder moved to approve C93-2025, Rock Crushing Services in Ross Pit. Commissioner Smith seconded. **VOTE:** KJS/MM all in favor. Motion approved.
- 3. Holly Miller, IT Director:
 - a) BEAD Grant Application Update, and the application is due on Monday, the 28th.
 - a. Commissioner Magruder moved to authorize the chair to sign the BEAD Grant application and related materials. Commissioner Smith seconded. **VOTE:** KJS/MM all in favor. Motion approved.
 - b) Holly Miller also discussed with the Board that 838 additional sites need to be added to the application process for the RDOF grant. The engineers will bill for actual cost, but have said they would like to do so without exceeding \$4000.00. Commissioner Magruder moved to approve the additional \$4000.00, and Commissioner Smith seconded. **VOTE:** KJS/MM all in favor. Motion approved.
 - c) At the end of March, we ran out of funds for the Broadband project with SNG. Given that we have extra funds in the Title 3 monies, Holly would like to pay the consultant for the work that they have continued to do. We have a current invoice for \$43,000.00. Commissioner Magruder moved to approve C96-2024-1 Personal Services Contract with Strategic Networks Group for Broadband Consultation (Phase 2). Commissioner Smith seconded. With the discussion, Commissioner Magruder is excited to make this all happen. Commissioner Smith is becoming increasingly more hesitant about this project. VOTE: KJS/MM all in favor. Motion approved.
 - d) Ed McGlone, Assistant County Counsel, gave the Board Resolution 47-2025 In the Matter of Declaring the Intention to Seek Reimbursement from Future Financing by a Potential Broadband Utility. Commissioner Magruder moved to approve 47-2025, and Commissioner Smith seconded. **VOTE:** KJS/MM all in favor. Motion approved.

4. Corey Padron, Emergency Management Director, is here to request approval of C110-2025, 2024 Urban Area Security Initiative (UASI) Subrecipient Agreement No. 32003378. The Board previously approved, and we applied for the 2024 USC grant for \$40,000.00 in community Emergency response team supplies. As we navigated the complexities of federal grants and funding, those grants were released and awarded to the City of Portland through the Oregon Office of Emergency Management. We have now been offered the \$40,000.00. Commissioner Magruder moved to approve C110-2025, 2024 Urban Area Security Initiative (UASI) Subrecipient Agreement No. 32003378 with the Chair to Sign. Commissioner Smith seconded. VOTE: KJS/MM all in favor. Motion approved.
