After discussion, Commissioner Garrett moved, and Commissioner Magruder seconded to authorize the opening of recruitment for a Transit Position. The motion carried unanimously.

- 3.** Sarah Hanson, County Counsel, and Carrie Garcia, HR Director, are here to discuss compensation.
  - a.** Commissioner Garrett moved, and Commissioner Smith seconded 73-2025 Order in the Matter of an Official Compensation Package for Food and Beverage- Position 1. Motion carried.

- b. Commissioner Magruder moved, and Commissioner Smith seconded 74-2025, Order in the Matter of an Official Compensation Package for Food and Beverage- Position 3. The motion carried.

Vote: KJS/MM in favor. Approved.

- c. Commissioner Garrett moved, and Commissioner Magruder seconded the approval of 75-2025, Order in the Matter of an Official Compensation Package for Food and Beverage- Position 2. The motion carried.

Vote: MM/CG in favor. Approved.

- d. Commissioner Garrett moved, and Commissioner Magruder seconded the approval of 76-2025, Order in the Matter of an Official Compensation Package for Food and Beverage Employees, Volunteers, and Elected. The motion carried unanimously.

Vote: KJS/MM/CG in favor. Approved.

- 4. Contract with Oregon Department of Justice, Sarah Hanson, County Counsel, is here looking for a one-month extension on C99-2025-1. After discussion, Commissioner Garrett moved, and Commissioner Magruder seconded the approval of C99-2025-1, Courthouse Improvement Intergovernmental Agreement OJD Contract No. 250198. The motion carried unanimously.

Vote: MM/CG in favor. Approved.

#### BOARD DISCUSSION

- Commissioner Smith would like to see about closing the John Gumm Door for December 26. Most staff and county functions in the John Gumm Building will be closed that day. Commissioner Magruder moved, and Commissioner Garrett seconded the closure of the front door of John Gumm on December 26. The motion carried unanimously.  
**Vote:** KJS/MM/CG in favor. Approved.
- Commissioner Smith would like to discuss the changes in the CET. I see the PUD is actively moving to reorganize, and I'm wondering what we, as a county, will do. They are having a meeting next week. Commissioner Garrett said CET will dissolve in the next few weeks. We will have more information coming. Commissioner Smith asked about the \$60,000 paid in October that could be refunded. Commissioner Garrett did not recommend that at this time, given that staff need to be paid. Commissioner Magruder agreed with Commissioner Garrett. Commissioner Smith stated that we be transparent with this transition and that their meeting be open to the public. Economic Development is very important to the County and is something that we need.




