DISCUSSION ITEMS

1. **Josh Pond, District Attorney, is here looking to open recruitment for the DDA I Position. The office is running on fumes, and we need to fill this position as soon as possible. We usually have two or three Victim Assistants, and we have one. We also usually have six to nine DDA's, and**

we currently have four, and the case load is not getting smaller. Commissioner Garrett moved, and Commissioner Magruder seconded to open recruitment for the DDA I position. Motion carried unanimously. Vote: KJS/MM/CG in favor. Approved.

2. Mike Russell, Public Works Director, along with Tatum Flowers, Solid Waste Coordinator. Is here to introduce Tatum and to discuss the transportation operations for the proposal process. We advertised proposals, and one proposal was received by January 13th. The current contract ends the first week of March, so we want to forego the process since we only received a proposal and went right into negotiations. Commissioner Garrett moved, and Commissioner Magruder seconded, to bypass the scoring procedure and authorize Mike Russell to issue notice of award at the appropriate time. Vote: KJS/MM/CG in favor. Approved.

COMMISSIONER MAGRUDER COMMENTS

We had a wonderful time in Salem with the Association of Oregon Counties, celebrating AOC's 120 years. The Association of Oregon Counties is building relationships with legislators, talking to them about our issues, and I think it was a successful day.
