REQUEST: Consideration of a Master Sign Plan application within the Commercial Zone for

Grandpa's Corner commercial center for: (1) One multi-tenant V-shaped, two-faced ground sign, 46-inches tall, with a stacked stone veneer base and external illumination via solar landscape spotlights; (2) One 24 square foot wall sign on the eastern façade of 7533-A Green Valley Road; (3) Projecting signs for 7533 Green Valley Road Units B-C, 7553 Green Valley Road, and 7559 Green Valley Road not to exceed a total 37.3 square feet; and (3) Find the project categorically exempt from the California Environmental Quality Act (CEQA) per CEQA Guidelines Section 15301 and Section

15303.
