Subject: Adopt a resolution authorizing the Chief of Police to purchase a 2013 Zero DS ZF11.4 PD – Demo Motorcycle from Eckhaus Fleet, LLC in the amount of \$14,362.00.

Background/Discussion: On February 10, 2015 the City Council approved an Equipment Lease-Purchase Agreement with Holman Capital Corporation for the purchase of capital outlay fleet equipment. Staff advised Council it would return to Council to confirm specific purchases under the agreement. The Police Department included \$80,000 for replacement of two patrol vehicles and \$42,036 for the purchase of two electric motorcycles.

The Chief advised Council during the meeting of an opportunity to possibly purchase a demo electric motorcycle at a significantly reduced rate. The Chief recommended purchasing the unit at a significant cost savings and then researching grant opportunities to assist with the purchase of a future motorcycle unit.


Staff has been able to secure the rights to purchase the 2013 Zero DS ZF11.4 PD – Demo Motorcycle from Eckhaus Fleet, LLC in the amount of \$14,362.00. Being this is a time sensitive item; staff has taken possession of the unit while seeking final Council purchasing approval.

Options: 1. Authorize the Chief of Police to purchase a 2013 Zero DS ZF11.4 PD – Demo Motorcycle from Eckhaus Fleet, LLC in the amount of \$14,362.00 from the prior approved Equipment Lease-Purchase Agreement with Holman Capital Corporation.
 2. Deny the purchase of the demo unit.

Cost: The total cost of the 2013 Zero DS ZF11.4 PD – Demo Motorcycle from Eckhaus Fleet, LLC is \$14,362.00. The City Council approved the Equipment Lease-Purchase Agreement with Holman Capital Corporation for the purchase of capital outlay fleet equipment which included a line item approving up to \$42,036 for this purchase category. The purchase of this unit at a cost of \$14,362.00 will come in significantly under the previously budgeted amount.

Budget Impact: No additional impact.

Recommendation: Adopt a resolution authorizing the Chief of Police to purchase a 2013 Zero DS ZF11.4 PD – Demo Motorcycle from Eckhaus Fleet, LLC in the amount of \$14,362.00.
