WHEREAS, the North Carolina Department of Transportation has made funds available for municipalities throughout the state to create bicycle plans through the NCDOT Bicycle and Pedestrian Planning Grant Initiative; and

WHEREAS, the Town of Archer Lodge recognizes the need for alternative types of transportation for citizens throughout the town; and

WHEREAS, it is incumbent that the governing body provide alternative types of multi-modal transportation for its citizens; and

WHEREAS, the Town of Archer Lodge recognizes the need for a comprehensive plan for approaching bicycle and pedestrian connections throughout the town;

**AMENDMENT TO ORDINANCE ON
THE ANNUAL CHRISTMAS PARADE
FOR THE TOWN OF ARCHER LODGE**

WHEREAS, on October 12, 2015, The Town of Archer Lodge adopted an ordinance that specified the date for the annual Christmas Parade within the municipal town limits; and

WHEREAS, the North Carolina Department of Transportation (NCDOT) requires for any municipal sponsored event impacting normal traffic flow, that an ordinance be passed approving the special event and a copy of the ordinance shall be forwarded to NCDOT; and;

WHEREAS, the Town of Archer Lodge has determined that it will continue the annual Christmas Parade; and

WHEREAS, this ordinance confirms that the Town of Archer Lodge is responsible for all aspects of the event, including safety and traffic related issues.

NOW THEREFORE, BE IT RESOLVED by the Archer Lodge Town Council:

In accordance with N.C.G.S. §20-169, the annual Christmas Parade is approved by the Archer Lodge Town Council and is to be held annually on the first Sunday following the Thanksgiving holiday at a time determined by Council.
