# V. Ongoing business

- Marker for Town Hall
  - Mr. Levendusky is waiting for a response from Commissioner Tucci regarding placement of the marker.
  - Mr. Intindola had a conversation with the Township grant writer and pointed out that funding is available for the markers and future ones through the New Jersey Historic Trust.

#### Vreeland House

- The Committee discussed the Township's ongoing project on the Vreeland Homestead grounds, a landmarked property. The project has included regrading for the construction of a gravel driveway linking the property to the Public Safety Building parking lot to the immediate north. As of the meeting, all of the vegetation behind the house had been removed, including a dead pine tree.
- o It was acknowledged that the Landmark only includes the house itself.
- Various concerns were raised including:
  - Possibility of a vehicle strike on the building due to limited clearance from the driveway.
  - Cumulative structural damage on the house due to regular traffic adjacent to the building's foundation
  - Obstructed sight lines posing a hazard to pedestrians
  - Diminished historic integrity due to encroachment of the driveway next to the building
- Mr. Levendusky is to write an email on the Committee's behalf expressing the above concerns to the Township.
- Nutley website pages for Nutley's landmarks
  - No update
- Additional properties for recruitment
  - Mrs. Van Steen has not reached out to the owners of the Bowser house since our last meeting.
  - Mr. Simko has had some communications with the owner of 330 Hillside, Joe Kollar
    - Landmarking process may start in October, when the daughter of the owner is set to return from abroad
  - Mr. Simko is also working on the first Nutley Public Library house on Passaic Avenue
