In the north end, a colony of native sassafras trees has sprung up among the overgrown invasives. Lack of hard frost this winter prevented DPW from bringing heavy equipment to clear invasives. Beginning to restore the Arboretum by mounting the existing tree name tags would be start Anna's goal (she would welcome!! help) goal to make the Arboretum another jewel in Teaneck's amenities.

DPW removed about 20 trees this month; • submitted (on time) Annual Accomplishment Report for Urban & Community Forestry program and the application to Tree City USA.; • M. beginning course to become LTE (Licensed Tree Expert) arborist (township not legally required to have one). • Bergen Academies' bare-root native redbuds to be planted on municipal green (about 5) and in Phelps Park (about ten) tentatively scheduled for April 22; • ordered replacement tree from Victoria's for Kevin's dead dogwood in Terhune Park (2022 Arbor Day); • Terhune Park destined to receive 30 newly ordered arborvitae "Green Giants (Thuja standishii x plicata 'Green Giant'); • Resiliency Grant: Davey Tree will be conducting UTC study for Teaneck
