

**CALL TO ORDER:**

Mayor Tim Wilson called the meeting to order at 7:00 p.m.

Present: Mayor Tim Wilson; Councilmembers: Ken Caylor, Dan Dever, Genna Dorow, Kenneth Johnson, Mark Snyder, and Marc Spohr.

**NPDES PERMIT FOR MOSQUITO CONTROL—TOM HAWORTH**

Tom Haworth, Manager of the Adams County Mosquito Control District explained that the Department of Ecology (DOE) is renewing their NPDES permit because the Mosquito District puts product into the water system. This permit process has been in effect for years. The DOE is trying to stop the spraying of adulticides and their residues used for nuisance mosquito control. The DOE has included in the NPDES permit that they cannot spray for adult nuisance mosquitoes. It would limit spraying for mosquitoes. He asked that Council consider sending a letter to Jon Jennings of DOE in support of the Adams County Mosquito Board's concerns relevant to the proposed NPDES regulations. A public hearing will be held on March 9<sup>th</sup>. Councilmember Johnson stated that it sounds that it would take someone getting sick before they would let them spray. Councilmember Caylor stated that the Mosquito District has done a good job controlling the mosquitoes and they made changes to not affect the local bees. Mayor Wilson thanked Mr. Haworth for his work and advised that the Council will vote on the issue at the next meeting.

**REVIEW OF PORT DISTRICT REQUEST FOR REIMBURSEMENT – SR 26/REYNOLDS WATER CROSSING**

Mayor Wilson announced that the Port District has requested that this be discussed at another meeting.

**CITY COUNCIL INTERVIEWS**

He showed the new rack card that advertises the Centennial weekend activities. He mentioned that the brick program was a success.

**UNFINISHED BUSINESS**

Councilmember Spohr stated that the Council can go into executive session before voting on the council vacancy. He reported that Paul Stoker of GWMA has given a report to the High School students about the decline in our water aquifers. Councilmember Caylor stated that is why we should support the Columbia Basin Extension project. Their program will provide an additional water source.
