SCHOOL RESOURCE OFFICER AGREEMENT WITH THE OTHELLO SCHOOL DISTRICT

Phil Schenck, Police Chief requests Council to renew the mutual aid agreement between the City and the Othello School District to keep a School Resource Officer present in the schools.

Councilman Everett recommends the Chief should talk to OSD about adding a third SRO in the schools. Due to recent events this may be a good time to talk about it.

AMENDMENT TO WEED SPRAYING CONTRACT WITH OUTBACK SPRAYING

As requested by Council, the Mayor met with Todd Barth with Outback Spraying regarding extending the current one year contact to a three year contract. Mayor Logan explained Todd Barth was willing to extend the contract for an additional two years and his new price offer for services for the extra two years would be \$42,340.50 per year.

Council consensus decided to decline that offer and keep the one year contract.
