BUDGET PROCESS AND PRELIMINARY COMMITTEE SCHEDULE

Spencer Williams, Finance Officer presents the preliminary budget committee schedule to the Council and notes some changes.

AWARD BIDS FOR CITY HALL REMODEL

Tim Unruh, Building Official presents the bids received for the City Hall remodel. There are four segments of bids which are Painting, Electrical, Carpentry, and Carpeting. The total of the bids received exceeded the amount Council approved for the remodel by \$24,302.66.

Council carried a motion to APPROVE ACCEPTANCE OF THE BIDS AND AWARD CONTRACTS IN THE TOTAL AMOUNT OF \$164,802.66. M/S Lallas/Quezada

2022 RCO- CERTIFICATION OF APPLICANT MATCH

Thalia Lemus, Grant Writer/Administrator explains the City applied for three grants for projects at Kiwanis Park. After receiving feedback, it was recommended the City increase the grant funding and increase the local match dollars which is a difference of \$83,262.00 from the original request.

Council carried a motion to APPROVE A LOCAL MATCH FOR RCO 2022 APPLICATIONS IN THE AMOUNT OF \$253,262.00 TOTAL. M/S Everett/Lallas

SEEK PROGRAM EXPENDITURES

Thalia Lemus, Grant Writer/Administrator explains the City only used half the funding received for the SEEK program during the four weeks of the Summer Sports Camp. AWC approved the City use the fall soccer season as part of the SEEK program allowing to purchase more equipment before September 30, 2022. Staff recommends to use the remaining funds for more park and recreation equipment requested by the Parks and Recreation Coordinator and media equipment.

Council carried a motion to APPROVE THE ADORAMA EXPENDITURE OF \$26,304.11 FOR MEDIA EQUIPMENT. M/S Lallas/Erickson

Council carried a motion to APPROVE AN EXPENDITURE UP TO \$48,000 FOR SPORTS EQUIPMENT THROUGH PROPHET CORPORATION. M/S Lallas/Everett

There was none.


