INTRODUCTION OF THALIA LEMUS

Mayor Logan introduces Thalia Lemus, the new Grant Writer Administrator. Thalia Lemus also gives more background about herself.

AWARD JANITORIAL BID TO A & H RENOVATIONS AND APPROVE CONTRACT

Tania Morelos, City Clerk presents a new contract for Janitorial services with A & H Renovation after advertising for bid proposals. One bid was received from A & H Renovation for \$2,000 a month.

Council carried a motion to AWARD JANITORIAL BID TO A & H RENOVATIONS EFFECTIVE FEBRUARY 1, 2021 AND APPROVE THE JANITOR CONTRACT. M/S Erickson/Dorow

RESOLUTION TO APPLY FOR AN INTEGRATED PLANNING GRANT AND ACCEPT THE DOE GRANT FOR PHASE 2 ESA

Mayor Logan presented a resolution to accept a DOE grant of up to \$32,000 for site assessments on property adjacent to City property and to authorize the Mayor to apply for additional funding under a DOE Integrated Planning Grant in the amount of \$200,000. The purpose of the IPG is to identify a plan and scope of work that will provide a firm estimation and steps to clean up the property.

Council carried a motion to APPROVE RESOLUTION 2021-1 TO AUTHORIZE THE MAYOR TO APPLY FOR DOE INTEGRATED PLANNING GRANT. M/S Lallas/Everett

PUBLIC HEARING ON RENTAL HOUSING LICENSING AND INSPECTION

Mayor Logan opened the Public Hearing at 7:06 p.m.

Anne Henning, Community Development Director presents an Ordinance creating a residential rental licensing and safety inspection program. This ordinance would be used as a tool for staff and code enforcement to ensure public health and monitor criminal activity.

Mayor Logan opened the public testimony for those in support, neutral, and opposed of the proposal.

Lolo Garza, 605 N. 12th Ave speaks in opposition of the Ordinance. Garza believes staff's intent of the proposed Ordinance is well, but it is "opening a can of worms" and thinks staff needs to spend more time to further review the language of the Ordinance.

Jose Garza 605 Danielle Rd suggests the Ordinance to have a term or trial and to see if it is effective or not "use as a foundation".

Leo Galleta, echoes points mentioned by Lolo Garza and Jose Garza. Galleta believes staff should collect more data and see how big the issues mentioned really are.

Much discussion ensued. Roger Enz and Chris Dorow from the Planning Commission weighed in on discussions.

Mayor Logan closed the Public Testimony at 7:54 p.m.

The Public Hearing was continued to February 1, 2021 at 6:30pm.

Mayor Logan asks the Landlords to submit written comments to staff over the week.

Councilman Snyder asks why roads were not salted today, roads were slick. Mayor Logan did not have answer at the moment will respond within the week.


