CURRENT BUSINESS

CONTINUED PUBLIC HEARING ON RENTAL HOUSING LICENSING AND INSPECTION

Mayor Logan opened the Public Hearing at 6:36 p.m.

Anne Henning, Community Development Director reminds Council of the issues previously discussed regarding Rental Housing in the community of Othello and the purpose of presenting to adopt the Rental Housing Licensing and Inspection Ordinance.

Kelly Konkright, City Attorney goes through the Ordinance and notes all the changes made to the Ordinance since the previous Public Hearing per staff or Council requests.

Mayor Logan opened the public testimony for those in support, neutral, and opposed of the proposal.

Eugene Bains, 645 N. 4th Ave. ask City Attorney why the time frame for the duration of the Ordinance is five years instead of six years if the inspections are done every three years.

Lolo Garza, 605 N. 12th Ave. forwarded an email to Mayor Logan by Leo Galleta and states he did not prepare that email with Mr. Galleta. Garza asks if email will be shared with Council. Mayor Logan says he will circulate email to entire Council. Garza is in favor of the "Sunset" Clause mentioned by the City Attorney.

Mayor Logan asks Council for their opinions regarding the Sunset Clause. Councilwoman Dorow believes changing the duration to six years instead of five as mentioned by Mr. Bain is a good idea.

Councilman Everett asks if the Ordinance will come back as review in five or six years or will it automatically “go away”. Councilman Snyder agrees Ordinance needs to be reviewed in six years.

Councilman Erickson has no comment. Councilwoman Quezada agrees with Councilman Everett and Snyder.

Further discussion and questions were asked to the City Attorney regarding the “Sunset” Clause.

Councilman Lallas is in opposition to the Ordinance and reserves his right to vote when it comes time to vote regarding the matter.

Mayor Logan closed the Public Testimony at 7:21 p.m.

Councilmen Everett and Snyder and Councilwomen Quezada and Dorow say no to the Sunset Clause.

Councilman Erickson is noted as “undecided” as he would like to see the Landlords comments before making a decision.

Heather Miller, Code Enforcement Officer explains how this Ordinance would be a tool.
