SEWER LAB EQUIPMENT PURCHASES

Jim Laird, Wastewater Treatment Operator requests Council approve \$75,000 from the sewer fund to purchase the necessary lab equipment to become accredited to run the City's own testing for Chlorine, DO, Ph, BOD, Fecal Coliform and Total Suspended Solids.
