CITY HALL REMODEL UPDATE

SEWER PROFESSIONAL SERVICES AGREEMENT

Shawn O'Brien, City Engineer requests Council approve the agreement with Anderson Perry for professional services.

Council carried a motion to APPROVE THE AGREEMENT FOR PROFESSIONAL SERVICES AND SCOPE OF WORK WITH ANDERSON PERRY & ASSOCIATES IN THE AMOUNT NOT TO EXCEED \$9,325 FOR TASK #1. M/S Erickson/Snyder
