PAID PRESENTATION

AWARD CHIP SEAL PROJECT-2023

Shawn O'Brien, City Engineer explains staff opened bids for the seal coat project and five bids were received. Staff recommends awarding the bid to Sierra Santa Fe Corporation which is under the engineers estimated cost for the project.

ADOPT RESOLUTION AMENDING CITY OF OTHELLO PURCHASING & BIDDING POLICY


- Erickson- There will be a request coming to discuss irrigation and water impacts bridges may have due to potential projects the city may have going on.
