PUBLIC HEARING FOR FENCING REGULATIONS AND ADOPT ORDINANCE 1596 AMENDING SECTIONS OF OMC 14.36 FENCES, WALLS, AND HEDGES

Anne Henning, Community Development Director gives a staff report and explains the proposed changes in the ordinance.

Mayor Logan opens the public hearing at 6:32pm.

Mayor Logan opens the public testimony. Jose Garza asks if chain link fences would reduce graffiti in town.

Mayor Logan closes the public hearing at 6:35pm.

Council carried a motion to ADOPT ORDINANCE 1596 AMENDING OMC 14.36 FENCES, WALLS, AND HEDGES, 17.30.100, COMMERCIAL ZONES; AND 17.40.090 INDUSTRIAL ZONES. M/S Erickson/Dorow

PUBLIC HEARING FOR LANDSCAPING REGULATIONS AND ADOPT ORDINANCE 1597 AMENDING SECTIONS OF OMC 17.74 LANDSCAPING AND SCREENING

Anne Henning, Community Development Director gives a staff report.

Mayor Logan opens the public hearing at 6:36pm.

Much discussion ensued between Council members.

Mayor Logan opened the Public testimony- Citizen Alvarez asks a question via zoom. The City Clerk reads the question for the Council.

Mayor Logan closes the public hearing at 7:21pm.

Council carried a motion to ADOPT ORDINANCE 1597 AMENDING OMC 17.74 LANDSCAPING AND SCREENING WITH THE REMOVAL OF THE CHANGES OF 17.74.150. M/S Erickson/Snyder

Councilwoman Dorow votes opposed to the motion.

ACCEPT NOTICE OF INTENT FOR OCHOA ANNEXATION

Anne Henning, Community Development Director explains the Ochoas have submitted a Notice of Intention to Commence Annexation Proceedings for 6 parcels east of 14th Avenue, between Main Street and Lee Road, 442.2 acres. Per RCW 35A.14.120 owners of not less than 10% of property proposed to be annexed shall notify the legislative body of their intention to commence annexation proceedings. If Council accepts the intention to annex, development of the site would go through the platting and building permit process, and comply with city codes.

Council carried a motion to ACCEPT TO MODIFY THE PROPOSED ANNEXATION. M/S Lallas/Dorow

Council carried a motion to REQUIRE THE SIMULTANEOUS ADOPTION OF PROPOSED ZONING OF C-2 COMMERCIAL ALONG MAIN STREET, I-1 (LIGHT INDUSTRIAL) ALONG LEE ROAD, AND R-4 RESIDENTIAL IN BETWEEN, MATCHING THE COMPREHENSIVE PLAN LAND USE DESIGNATIONS. M/S Lallas/Dorow

Council carried a motion to REQUIRE THE ASSUMPTION OF EXISTING CITY INDEBTEDNESS BY THE AREA TO BE ANNEXED. M/S Lallas/Dorow

NATIONAL DAY OF PRAYER PROCLAMATION

Mayor Logan reads the proclamation for the 2023 National Day of Prayer which will take place on May 4th at noon at City Hall.

APPROVE CONTRACT WITH LIGHTHOUSE COMMUNITY CENTER FOR INTERVENTION AND MENTORING SERVICES

Dave Rehaume, Assistant Chief of Police introduces Angela Kudsk who wishes to take over the mentoring services at Lighthouse Community Center for youth. Angela gives a presentation of the services that will be provided and requests Council to approve the agreement between Lighthouse and the City which staff has reviewed and accepted as well.

Council carried a motion to APPROVE THE TWO-YEAR AGREEMENT WITH LIGHTHOUSE COMMUNITY CENTER FOR MENTORING AND INTERVENTION SERVICES. M/S Dorow/Snyder

APPROVE MEMORANDUM OF UNDERSTANDING WITH THE FEDERAL BUREAU OF INVESTIGATION FOR CHILD EXPLOITATION AND HUMAN TRAFFICKING TASK FORCE

Dave Rehaume, Assistant Chief of Police requests approval of the MOU with the FBI for participation in the Spokane Task Force.

Council carried a motion to APPROVE THE MEMORANDUM OF UNDERSTANDING WITH THE FBI FOR PARTICIPATION IN THE SPOKANE FBI TASK FORCE. M/S Erickson/Lallas

MARINERS LITTLE LEAGUE SPECIAL PROMOTION

Valerie Hernandez, Park and Recreation Coordinator informs Council the City will advertise a promotion by the Seattle Mariners where the City Little League will earn \$1 for every ticket purchased to their game and the children will be able to participate in the Mariners Parade.

REPTILE PRESENTATION AT KIWANIS PARK

Valerie Hernandez, Park and Recreation Coordinator informs Council there will be a collaborative show/event with the Mid-Columbia Library at Kiwanis Park with Reptile lady.

APPROVE PURCHASE OF IWORQ SYSTEMS AND PRESENTATION

Curt Carpenter, Public Works Director along with a representative from iWorq Systems presents to Council the features of the software which would allow public works to track many daily projects, keep inventory, assign work orders, etc.

Council carried a motion to APPROVE THE SERVICE AGREEMENT WITH IWORQ SYSTEMS FOR A THREE-YEAR TERM FOR A TOTAL OF \$66,000. M/S Dorow/Valdez

APPROVE PURCHASE OF FIRE SUPPRESSION HOOD, GRILLS, AND DEEP FRYERS FOR LIONS PARK CONCESSION STANDS

Curt Carpenter, Public Works Director explains the City has advertised for proposals to lease the pool and ballfield concession stands and the city would receive a percentage of the profits. In order to have an appropriately equipped concession stand for vendors to use. Staff recommends the purchase of commercial kitchen items to be installed in the concession stands.

Council carried a motion to APPROVE THE PURCHASE OF FIRE SUPPRESSION HOOD, GRILLS, AND DEEP FRYERS USING (103 & 104) FUNDS IN THE AMOUNT OF \$65,600.00. M/S Valdez/Garza

AWARD SOD REMOVAL PROJECT

Shawn O'Brien, City Engineer explains the City opened quotes for a sod removal project where they will remove healthy sod from Lions park where the new trail will be installed and use the

sod at Taggares park at areas needs. Staff recommends council to award the project to Northwest Turf Solutions.

Council carried a motion to AWARD THE QUOTE FOR THE SOD REMOVAL PROJECT TO NORTHWEST TURF SOLUTIONS, INC. IN THE AMOUNT OF \$8,210.22. M/S Dorow/Valdez

APPROVE CHANGE ORDER TO THE SEAL COAT PROJECT CONTRACT WITH SIERRA SANTA FE CORPORATION

Shawn O'Brien, City Engineer explains Sierra Santa Fe Corporation proposed adding a scrub seal to the section of North Broadway from Fir Street to Lee Street for the 2023 seal coat project. North Broadway is overdue for maintenance work, but a simple seal coat will provide limited benefits. Staff recommends Council approve the change order.

Council carried a motion to APPROVE THE CHANGE ORDER TO THE SEAL COAT PROJECT CONTRACT WITH SIERRA SANTA FE CORPORATION. M/S Snyder/Erickson

APPROVE PURCHASE OF A LIFT AND MECHANIC TOOLS FOR PUBLIC WORKS MOTOR POOL

Curt Carpenter, Public Works Director explains with the new lead positions at Public Works the Motor Pool Lead is in need of tools. Staff requests Council approve the purchase of tools and lift with the remaining budget.

Council carried a motion to APPROVE THE PURCHASE OF A LIFT AND MECHANIC TOOLS FOR MOTOR POOL WITH THE REMAINING FUNDS AMOUNT OF \$87,640.00. M/S Erickson/Dorow

SAND HILL ESTATES V VARIANCE REQUEST AND REQUEST FOR CITY PARTICIPATION

Shawn O'Brien, City Engineer explains a variance is being requested to not install curbing and gutter and sidewalk on the East side of 14th Avenue through the Sand Hill Estates V Development.

Council suggests staff and committee members discuss this in a meeting before making a decision.
