CURRENT BUSINESS

Approve Resolution 2023-10 Supporting EMS Levy

Bob Carlson, Board Commissioner of the Othello Community Hospital states that this levy is to keep the ambulance services in the City of Othello and they are not changing anything in the levy they are just asking to renew it for another 6 years which still staying at \$.40 per \$1000. Mr. Carlson stated that they are asking the city for another resolution in support of the levy for another 6 years.

Council carried a motion to APPROVE RESOLUTION 2023-10 SUPPORTING EMS LEVY M/S Everett/Dorow. The motion carried 6-0

Approve Benton County Jail Agreement

Interim Chief Dave Rehaume stated that the Othello Police Department is seeking a second jail contract. The second contract would allow OPD Officers to transport arrestees to the Benton County Jail. This facility provides additional space and options for holding arrestees when space is not available at other locations. The request has been reviewed by legal and insurance representatives. The cost is approximately \$45 per day at the Benton County Jail.

Council carried a motion to APPROVE BENTON COUNTY JAIL AGREEMENT M/S Snyder/Garza. The motion carried 6-0.

APPOINTMENT OF NEW CHIEF OF POLICE

Mayor Shawn Logan recommended to the Othello City Council to authorize him to appoint David Rehaume as Police Chief of the City of Othello. Mayor Logan stated that after meeting with Rehaume he was impressed with his preparation, enthusiasm and his compassion for the department and the community. After much contemplation and consideration Mayor Logan stated that Rehaume has earned his opportunity.

Council carried a motion to APPROVE THE MAYOR'S APPOINTMENT OF DAVID REHAUME AS POLICE CHIEF OF THE CITY OF OTHELLO AND AUTHORIZES THE MAYOR TO ADMINISTER THE OATH OF OFFICE. M/S Lallas/Dorow. The motion carried 6-0.


