ADAMS COUNTY PARK AND RECREATION DISTRICT NO. 1 DONATION FOR SIGN AT TAGGARES PARK

Rolando Cerrillo president of the Adams County Park and Recreation District No. 1 announces they are donating \$5,000 to the City of Othello for a new sign at Taggares Park and thanks the City for the improvements made to the park.

APPROVE PUBLIC WORKS BUILDING REPAIRS

Mayor Logan explains staff is still working on a long term plan for holding dogs but in the meantime is looking to hold dogs in the Public Works Building #2. Improvements to the building will need to be made to hold 8 dogs there but these improvements will benefit Public Works in the long run once the dogs are removed.

Council carried a motion to APPROVE PUBLIC WORKS DEPARTMENT TO MAKE LONG TERM IMPROVEMENTS TO BUILDING WHERE EQUIPMENT IS STORED IN AMOUNT TO NOT EXCEED \$12,000. M/S Lallas/Dorow

APPROVE CITY ATTORNEY CONTRACT

Mayor Logan presents a contract between the City of Othello and Kenyon-Disend, LLC for legal services. An RFP was conducted and 4 different proposals and interviews were made. Staff recommends Council approve Kenyon-Disend, LLC as the City's new legal counsel.

Council carried a motion to AUTHORIZE THE MAYOR TO SIGN THE AGREEMENT FOR LEGAL SERVICES WITH THE LAW FIRM OF KENYON-DISEND, PLLC. M/S Dorow/Lallas

DISCUSSION: CARGO CONTAINERS

Anne Henning, Community Development Director presents the recommendations made by the Planning Commission regarding Cargo containers in C-1 zones and other issues on containers in different zones. Henning requests direction from the Council so that updates can be made to the ordinance and schedule a public hearing.
