CURRENT BUSINESS

ORDINANCE AMENDING OTHELLO MUNICIPAL CODE SECTION 4.36 TITLED "PUBLIC DANCES"

City Clerk Rebecca Ozuna mentioned that over the years there have been some issues with security, time of public dances and the requirements needed to obtain a public dance permit and that the current ordinance has been an effect since 2003 which started that they (City Hall and Police Department) have discussions in great length the necessity of updating the ordinance to ensure the safety and welfare of our citizens and make sure that process to obtain a permit is more streamline. Ms. Ozuna presented Council an ordinance with multiple updates recommended by personnel from City Hall, Police Department and has been reviewed by the City Attorney.

Council made a motion to ADOPT THE ORDINANCE AMENDING SECTION OTHELLO MUNICIPAL CODE CHAPTER 4.36 TITLED "PUBLIC DANCES" WITH A GRAMMAR CORRECTION. M/S Everett/McCourtie. This shall be known as Ordinance No. 1514

RESOLUTION TO AWARD BID FOR OFFICIAL NEWSPAPER

City Clerk Rebeca Ozuna reported that every year the City calls for bids for official newspaper and this year bids were sent out on June 14th and were accepted up to 12:00 p.m. on June 29th, 2018.

We received the following bid:

- The Sun Tribune \$8.15 per single column inch

Ms. Ozuna mentioned that last year the City spent about \$10,200 on legal publications not including advertisements and recommended the Council award the official newspaper to the Sun tribune.

Council carried a motion to APPROVE THE RESOLUTION TO AWARD THE OFFICIAL NEWSPAPER TO THE SUN TRIBUNE. M/S Bain/Lallas. This shall be known as Resolution No. 2018-14.

RESOLUTION AND FACILITY USE AGREEMENT BETWEEN CITY OF OTHELLO AND ALL CITIES CAR CLUB FOR CAR SHOW AND SPUD RUN

Parks and Recreation Coordinator Amy Hurlbut reported that the All Cities Classic Car Club is preparing for their annual "Spud Run" and car show, scheduled for July 20th – 21st, 2018. Preliminary plans include the parade of cars on Friday, July 20th on Main Street between 6:00 p.m. and 9:00 p.m. The club is requesting to close off Main Street from 4th Avenue to 7th Avenue for this event as they did in 2017. The car show will be held in Kiwanis Park on Saturday, July 21st from 6:00 a.m. to 5:00 p.m. The All Cities Classic Car Club will incur the \$200 Special Event fee for use of Kiwanis Park.

Council made a motion to APPROVE THE RESOLUTION AUTHORIZING USE OF CITY PROPERTY FOR THE OTHELLO CHAPTER OF THE ALL CITIES CLASSIC CAR CLUB'S ANNUAL "SPUD RUN" AND CAR SHOW. M/S Snyder/Lallas. This shall be known as Resolution No. 2018-15

RESOLUTION AND FACILITY USE AGREEMENT BETWEEN CITY OF OTHELLO AND AMERICAN CANCER SOCIETY FOR RELAY FOR LIFE

Park and Recreation Coordinator Amy Hurlbut mentioned that this year's Relay for Life event will be presented differently, after a transition to a DIY event model was rolled out by the American Cancer Society. Othello relay for life had chosen to have a festival type event in the center of town at Pioneer Park. Set up for the event will begin at 9am. The event will be from 3pm-11pm and cleanup will be done by 12am. This will not be an overnight event like it has been in the past. There will still be many recognizable traditions such as survivor's dinner and luminaria, as well as team booth set up earning money for the event's cause. The American Cancer Society will incur the \$200 Special Event fee for use of Pioneer Park.

Council made a motion to APPROVE THE RESOLUTION AUTHORIZING THE USE OF LIONS PARK BY THE AMERICAN CANCER SOCIETY IN COORDINATION WITH THE RELAY FOR LIFE EVENT COMMITTEE ON JULY 21, 2018 FOR THE ANNUAL RELAY FOR LIFE EVENT. M/S Lallas/McCourtie. This shall be known as Resolution No. 2018-16

RESOLUTION AND FACILITY USE AGREEMENT BETWEEN CITY OF OTHELLO AND GREATER OTHELLO CHAMBER OF COMMERCE FOR FARMERS MARKET

Parks and Recreation Coordinator Amy Hurlbut reported that the Othello Chamber of Commerce wants to continue to manage the Farmer's Market. They requested to use a dedicated portion of Pioneer Park every Thursday from 3:00 p.m. to 8:00 p.m., July 12th, 2018 through October 25th, 2018. The Greater Othello Chamber of Commerce will incur the \$200 Special Event fee for use of Pioneer Park.

Council carried a motion to APPROVE THE FACILITY USE AGREEMENT BETWEEN THE CITY OF OTHELLO AND THE GREATER OTHELLO CHAMBER OF COMMERCE FOR USE OF PIONEER PARK TO

OPERATE THE 2018 FARMER'S MARKET. M/S Snyder/Bain. This shall be known as Resolution No. 2018-17.

PURCHASE POLICY DISCUSSION

Finance Officer Spencer Williams presented to Council a draft purchase policy for them to review. Mr. Williams commented that the City has good practices in place to govern how City money is spent and that there are pieces of a policy in different places, but not one all-inclusive document to codify our practices. We compiled a policy that we believe captures the Council's desires and this document is a draft.

Mr. Williams stated that putting a policy like this together can be tricky. We've seen examples that are tighter and looser, depending on the comfort level of the respective council. This policy was reviewed by the Finance Committee and our attorney and changes at both levels were implemented into this document. Mr. Williams mentioned that his vision tonight is to review this document, then you as council members can discuss the portions that you are comfortable with and what you would like to change. This is very much a collaborative effort and should reflect your desires as the City Council.

OTHELLO SAND HILL CRANE FESTIVAL DEBRIEF

Sand Hill Crane Festival Co-Chairs Chris and Kurt Braunwart gave a brief overview of the Sand Hill Crane Festival held in March 2018 and all the feedback they received from surveys received. Mayor Logan also gave a brief overview of his personal experience in attending the festival and also being asked to participate.

Mayor Logan announced that Council will now adjourn at 7:19 pm to go into an executive session pursuant to RCW 42.30.110(g) to review the performance of a public employee. The executive session is expected to last 15 minutes. No action will be taken during the executive session.
