Mayor Logan gives a brief summary of the background of what led the City to do a study on our current and future water supply. Tim Flynn along with Andrew Austreng gives Council a report on the status of the ASR Program status supported by a PowerPoint presentation.

Kelly Konkright, City Attorney recommends that the public hearing should be closed and gives Council direction on their options how to proceed with the Public Hearing in order to close the hearing.

ANNEXATION OF WELL 10 SITE

Anne Henning, Community Development Director explains an annexation for a property the City owns identified as Tax Parcel 2100490072372 is needed in order to start drilling for Well 10 Site. The reason for this is because this property is currently in County jurisdiction rather than City jurisdiction. Staff recommends approving Ordinance 1530.
