PUBLIC HEARING TO ADOPT NEW CHAPTER 12.44 IRRIGATION WATER, ADOPT A NEW SECTION 12.04.120 IRRIGATION WATER, AND AMEND 12.04, 12.16, 12.40

Shawn O'Brien, City Engineer explains that Council and the Water, Sewer, Street committee have supported the idea of establishing an irrigation system utility to reduce the City's reliance on groundwater sources. In order to do this staff has worked with attorneys to prepare amendments to the current OMC. Staff recommends Council approve the proposed Ordinance 1531.

Councilman Bain addressed a few areas in the proposed Ordinance that need to be reworded or amended. O'Brien made note of the corrections.
