### **PROCLAMATION FOR KINDNESS WEEK**

Mayor Logan reads the Proclamation announcing October 13<sup>th</sup> through October 20<sup>th</sup> Kindness Week in Othello. Lisa Lutey gives a brief background of what Kindness week is about and informs Council of the events that will hold place throughout the week.

### **UPDATE BUILDING CODE ADOPTION**

Community Development Director, Anne Henning explains to Council the International Codes are updated every three years. Over time, as sections are added, deleted, and modified, there are some mismatches, both in code numbers and in content. The code adoption sections of OMC 14.04 have not been updated since 2007, so some changes are needed. Staff was directed on how to prepare the Ordinance Amending OMC 14.04, Building Codes.

### **DISCUSSION ON ZONING UPDATE**

Community Development Director, Anne Henning explains the Planning Commission has prepared potential changes in zoning that they believe will be more modern, user-friendly zoning code, and a more logical zoning map. These potential changes have been discussed by Council in past meetings and there are still a few issues which need further discussion. Council discussed the remaining zoning issues and provided direction to staff on how to prepare the zoning ordinances and to properly inform the public of the potential changes before a Public Hearing.

## **UNFINISHED BUSINESS**

Councilman Bain asks about the status of painting City Hall's front doors. Mayor Logan said Public Works is working on the appropriate date and time to complete the project due to the weather.

Councilwoman Quezada mentions she was driving on Main and Broadway and was stopped at the traffic light for eight minutes. Mayor Logan says experts are looking into.
