FIREWORKS REPORT

Phil Schenck, Police Chief reports back to Council on the previously brought up issue of the Fireworks Ordinance on January 6, 2020 Council meeting during Citizen Input. Council suggests this issue needs to be revisited and make the public aware there is a possibility of banning or changing the current ordinance. Educating the public of the ordinance also needs to be done.

SAGESTONE 8 PHASE 2 FINAL PLAT

Anne Henning, Community Development Director presents to Council the proposed final plat drawing and comments received which needed to be addressed before approval of the plat.

CONTINUED PUBLIC HEARING ON ZONING UPDATE

Mayor Logan opened the Public Hearing at 7:00 p.m.

Anne Henning, Community Development Director once again summarizes the history of the ongoing public hearings and explains that all the changes being proposed represent a significant step forward for the community with a more modern, user friendly zoning code and a more

logical zoning map. There were many items to address during the Public Hearing. Henning lists all the issue before Council needing discussion tonight.

Mayor Logan opened the public testimony at 7:08 pm.

Dr. Chris Hurst, Othello School District Superintendent reads a letter requesting Council to allow time for City Employees and School District Employees to collaborate to come up with options finding the appropriate solution for a new school for students.

Councilman Erickson asks questions regarding the School Levy. Councilman Lallas mentions Lee Road is a truck route to McCains and other factories in that area and questions if the school district has put into consideration that they are wanting to build a school in a truck route.

Mayor Logan clarifies to Council that the school district just asking for time to collaborate he does not believe that districts request is unreasonable, "they are not trying to stall us or slow us down the district just wants to discuss and make some considerations as they plan for their schools future".

Discussion and suggestions from the Public ensued.

Mayor Logan closed the Public testimony at 7:41pm.

Questions and discussion ensued between Councilmembers and Henning regarding the items to be addressed.

Mayor Logan closed the Public Hearing at 7:55pm. The Public Hearing was continued to February 10, 2020.
