Lesser Markers at Corners of Significant Land Claims: Jill Bonney-Hill reported that the Pastor at Faith Lutheran had signed the necessary contract and she had forwarded it to Bill Lawyer of Public Works. He was going to give it to the City Attorney for review but she hasn't heard back. She will follow up with Mr. Johnson.

LICENSE TO USE REAL PROPERTY TO DISPLAY HISTORICAL MARKER

This agreement is entered into this 8th day of May, 2019 by and between Faith Lutheran Church (hereinafter "Licensor") and the City of Keizer, an Oregon municipal corporation, (hereinafter "City").

WHEREAS, the City is sharing the City of Keizer's history with the general public;

WHEREAS, Licensor has agreed to allow the City to use a portion of Licensor's property to publicly display a historical marker sharing the City of Keizer's history with the general public.

THE PARTIES AGREE AS FOLLOWS:

1. Licensor hereby permits and licenses the City to enter upon the following referenced real property for the purposes and subject to the limitations set forth in this Agreement:

The real property located at 4505 River Road North, Keizer on the east side adjacent to the sidewalk as approved by Licensor.

2. The City may use the described portion of Licensor's property only for the purpose of installing, maintaining, displaying and removing the historical marker.

3. Licensor shall approve the selection of the historical marker in writing prior to installation or any change in the marker.

4. This License shall commence on April 29, 2019 and shall terminate on April 28, 2024. However, this License shall automatically renew for additional five year terms unless written notice of non-renewal is given by one party to the other party not later than thirty (30) days prior to the end of each term.

5. The method of installation of the historical marker shall be as follows:

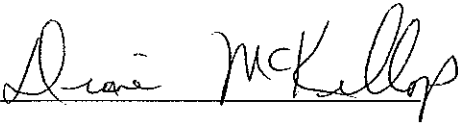
City shall install a 4"x4" sign (historical marker) on a post. Upon termination of this License, the sign and post shall be removed and the area re-landscaped with new plant material to match the adjacent area.

6. The historical marker displayed pursuant to this Agreement shall remain the property of the City.

7. All risk of loss to the historical marker shall be that of the City.
8. Proper installation and removal, and all associated costs and expenses, shall be the responsibility of the City.
9. City's interest hereunder is freely transferable to a responsible non-profit entity without prior consent of Licensor.
10. The City acknowledges that Licensor shall continue to use the Subject Property in the manner in which Licensor is currently using the Subject Property and City shall conduct its activities upon the Subject Property in such a manner so as not to interfere with Licensor's activities upon the Subject Property, including keeping the licensed areas and Licensor's adjacent property free of equipment and materials at all times, except when workmen are actively working in the licensed areas for installing, removing or maintaining the historical marker.
11. No later than the date of termination of this License, the historical marker shall be removed and the condition of the portion of the premises on which the historical marker was displayed shall be restored to substantially the same or similar condition as existed prior to the display within a reasonable time after the completion of the removal thereof.
12. To the extent permitted by the Oregon Constitution, and subject to the limitations of the Oregon Tort Claims Act, the City shall defend and indemnify the Licensor, its officers, agents and employees, harmless against all liability, loss, or expenses, including attorney's fees, and against all claims actions or judgments based upon or arising out of damage or injury (including death) to persons or property caused by the City's negligent or intentional act or omission sustained in any way in connection with the use of this License, including the condition of the historical marker, unless arising out of the intentional or negligent act of the Licensor, its officers, agents or employees.
13. The consideration for this License is: \$0.00; it is being granted by Licensor for civic purposes. City acknowledges that it is expending public monies on improvements being made on and to private property and that such improvements may increase the value of such property. Notwithstanding the foregoing, City specifically waives any rights it may have to claim that as a result of such expenditure or the rights granted hereunder or otherwise, it has acquired a possessory interest in the Subject Property or is entitled to a property interest therein and agrees that it has no interest in or right to any compensation from Licensor or the owner of the Subject Property as a result of such expenditure.

14. This License represents the full, entire and complete agreement of the parties, except as may be otherwise provided in writing.

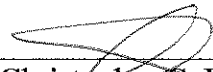
