**APPROVAL OF MINUTES** ~ Jennifer Thomas moved for approval of the August 2018 Minutes. Ashley Wenger seconded. Motion passed as follows: Bonney-Hill, Iken, Gottfried and Thomas in favor with Wenger abstaining, Busch absent at time of vote and Tamayo absent.

**NEW/OLD BUSINESS** ~ None

**PROJECTS/REPORTS**

**Lesser Markers at Corners of Significant Land Claims:** Jill Bonney-Hill reported that Pastor Linda of Faith Lutheran Church had indicated that she was interested in working with the committee to have a marker put on their property but she would have to bring it to the Church Council which meets on October 11. Ms. Bonney-Hill volunteered to attend the meeting. Discussion took place regarding details of the signage: a post with a marker on top or a sign on the building. Members agreed that this could be discussed after checking to see if an easement would be needed and the process involved in that.

**Oral History Update:** Jill Bonney-Hill volunteered to contact Anita Zahniser about the possibility of working together on this project.

**Cavalry Remount Station:** Sherrie Gottfried reported that she had sent another email to State Archivist Marybeth Herkert on September 26 but had not heard back.

**Informational Signage at Keizer School:** Jill Bonney-Hill reported that she is going to try to meet with Tammy Wilde at the museum on October 15.

**Informational Signage at Schoolhouse Square:** Sherrie Gottfried reported that there has been a change in management of that property. Her contact indicated that they would not be amenable to a sign on the building. Members agreed to put this issue on hold until a tenant is in the building.

**Neighborhood History/Origination of Street Names:** Jennifer Thomas asked for and received clarification on the project.

**Facebook Page:** Jennifer Thomas reported that she is trying to figure out how to get more coverage without having to pay an extra fee. Chair Gottfried urged all members to invite their contacts to the page. She urged Ms. Thomas to invite Keizer area neighborhood associations to like the KPIC Facebook page.

**Willamette University:** Liezle Tamayo was not at the meeting – No Report.

**Longitude 123:** Ashley Wenger reported that she had emailed David Loudon but received no response. Jill Bonney-Hill volunteered to work with Ashley on this project and take it over when Ashley's term expires.

**Claggett Creek Watershed Council Story Map Project:** Bob Busch reported that plans on attending a Claggett Creek Watershed Council meeting in October. He noted that Richard, the owner of the 911 Supply Store is going to do the aerial mapping for CCWS but they are not sure what they want to do next with the Story Map project.

**OTHER BUSINESS:** Jill Bonney-Hill questioned if the committee wanted to pursue putting a marker at the location of the John Keizer house. She said that David Loudon had told her it is 100 feet west of Shoreline and 66 feet north of Cummings. Committee members checked their phone maps and indicated that they would explore this possibility.
