Regular Session
June 26, 2017
Benton Municipal Complex

The Benton City Council was called to order at 7:02 pm.

The Mayor gave the invocation.

Alderman Hamm led the pledge of allegiance.

Roll was called.

When roll was called eight (8) council members were present. Alderman Lee was absent. Alderman Cunningham's position will be filled tonight. A quorum was declared.

The Mayor requested approval for the June 12, 2017 city council meeting minutes. Alderman Hart made a motion to approve the minutes, seconded by Alderman Reed. The Mayor called for a voice vote on the approval of the minutes. All aldermen present replied in the affirmative. The minutes for the June 12, 2017 council meeting were approved with 8 affirmative and 2 absent votes.

Jennifer Picklesimer was not present for her service award for 10 years with the city.

The next item on the agenda was Resolution 58 of 2017 – A Resolution Ratifying and Confirming the Appointment of Jocelyn Cash to Fill the Vacancy in Benton City Council Position Ward Two, Position One; and for Other Purposes. Alderman Donnor made a motion to adopt Resolution 58 of 2017, seconded by Alderman Ponder. The resolution was read by the city clerk. The Mayor asked that the roll be called which resulted in Alderman Baptist yes, Alderman Murphy yes, Alderman Cunningham absent, Alderman Reed yes, Alderman Donnor yes, Alderman Ponder yes, Alderman Hart yes, Alderman Herzfeld yes, Alderman Lee absent, and Alderman Hamm yes. Resolution 58 of 2017 was approved with 8 affirmative and 2 absent votes.

The Mayor swore in Jocelyn Cash for the vacancy left by Alderman Cunningham.

Alderman Reed made a motion for Alderman Cash to serve on the same committees as Alderman Cunningham, the parks committee and the finance committee. Seconded by Alderman Donnor. A voice vote was taken on the motion. All aldermen present replied in the affirmative, motion was approved with 9 affirmative and 1 absent vote.

#### V. OLD BUSINESS

Early Bond Retirement Payment

Jerry Ponder reported that the City Council approved the resolution that had resulted from the A&P request that 1 million 750 thousand dollars be used for early retirement of Event Center bonds in August. He noted that this payment will result in an approximate savings of \$702,000 on the Event Center. Early retirement can only occur on August 1 and February 1. He presented information about the various accounts from which the August 1 payment could be secured. He made the motion that the money be secured as follows:

#### VII. FUNDING REQUESTS

2017 Update on Funding:

An update on 2017 Funding Requests and Payments was presented to the commissioners.

#### Funding Request 1: Farmers' Market

Mayor Mattingly spoke to a request from the City for funding for the proposed Farmers' Market. Placement of the Farmers' Market will be on property that has been secured with a 10-year lease. The proposed cost of the structure is now \$450,000 because of the cost of adding a bathroom. At this time \$394,000 has been raised through sponsorships and donations. First Security will be the lender on the project. Some donors will pay their pledged amount over a 2-or-3 year period. Approximately \$150,000 of the project is through pro bono (city only pays for materials; labor will be donated). Some off-street parking has been secured.

City Attorney Brent Houston informed the commission that in order for it to give money toward the building, the city "would have to own an interest" in the building. The money must "go into the city-owned structure." He also said there would have to be two motions for the A&P to offer any funding-- Motion 1. Recognize the Farmers' Market as a public building; Motion 2. State the amount to be funded to the building.

Official vote on the request will be done at the July meeting.

#### Funding Request 2: Amplify

Josh Turner, co-chairman of Amplify spoke to the request for funding for the 2017 Amplify Festival. He shared a video of the 2016 event. He indicated this is the largest state festival held. A new addition this year will be a conference for youth to be held in River Center on Saturday. Advertising is planned to cover the state with television coverage and billboards. Social media will be used. Some out-of-state advertising will be done. A proposed budget for the 2017 event was attached to the funding request.

Commissioners stated that according to our A&P guidelines, event spending should be with Benton businesses when possible.

City Attorney Brent Houston stated that if funding is given, the motion should include that the money is being given for advertising and economic impact for the City.

Official vote on the request will be done at the July meeting.

# VIII. ADMINISTRATIVE Industry Comparison None

#### Past Dues

Jerry Ponder informed the group that delinquencies have improved. From financials reports, revenue from A&P tax has been rising. Past-Due Offenders' names have appeared in the newspaper.

#### IX. FINANCIAL REPORTS

The financial reports were presented by Gary James. Total assets as of May 31, 2017 for the A&P Commission and the Event Center in the Operating Account is \$512,409.68. A&P shows a net income of \$2,719.10 for the month and a loss of \$238.42 for the year. The Event Center shows a net income of \$16,606.20 for the month of May; the yearly net income is \$83,502.13. Without A&P tax deposits, the Event Center's net income for the year is \$35,369.56.



# ORDINANCE NO. 35 OF 2017

AN ORDINANCE WAIVING COMPETITIVE BIDDING AND AUTHORIZING AND RATIFYING THE PURCHASE OF ALL PARTS AND EQUIPMENT TO REPLACE TWO DECANT CLARIFIERS LOCATED AT THE WASTEWATER TREATMENT PLANT OF BENTON UTILITIES WASTEWATER TREATMENT DEPARTMENT; DECLARING AN EMERGENCY; AND, FOR OTHER PURPOSES

WHEREAS, The Mayor and the City Council of the City of Benton, Arkansas have determined that the City should purchase all parts and equipment needed to replace digesters 1 and 2 at the Benton Utilities Wastewater Treatment Department without competitive bidding in connection therewith; and

WHEREAS, The City Council wishes to authorize and approve transaction described below;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Benton, Arkansas, that:

SECTION 1. It is in the best interest of the City to contract with WesTech Equipment at 3665 S West Temple, Salt Lake City, UT 84115 to purchase all parts and equipment necessary to replace digesters 1 and 2 at the Wastewater Treatment Department. Copies of said quote and supporting documents are attached to this ordinance and incorporated herein by reference. The Wastewater Treatment Plant Department is authorized and directed to contract with WesTech Equipment at a total cost not to exceed \$624,502.00. All actions of the Benton Utilities Wastewater Treatment Plant Department in pursuing the contract authorized herein from WesTech Equipment prior to the formal adoption of this ordinance are hereby confirmed, ratified and approved.

SECTION 2. The requirement of competitive bidding for the purchase hereby authorized is deemed not feasible or practical due to the weather and time

restraints that limit this project as well as a limited number of companies available to do the work and, therefore, is waived.

SECTION 3. The Mayor and City Clerk are hereby authorized and directed to execute such additional documentation as may be necessary or convenient to affect the purposes of this ordinance.

SECTION 4. The immediate entry into, implementation of, and payment for all labor and materials to purchase the above listed items from WesTech Equipment are authorized herein, and the ratification of actions taken to date, are necessary for the City to properly and timely perform tasks required of the Benton Utilities Wastewater Treatment Department currently underway, and any delay in the same adds intolerable inconvenience to the delivery of necessary services to the public. Therefore, an emergency exists, and this ordinance is necessary for the preservation of the public peace, health and safety. It shall be in full force and effect immediately from and after its passage and approval.

## ORDINANCE NO. 36 OF 2017

AN ORDINANCE AMENDING ORDINANCE 71 OF 2015; CORRECTING A SCRIVENER'S ERROR IN SECTION 1 OF THE ORDINANCE; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES

WHEREAS, the City Council of the City of Benton, Arkansas passed Ordinance 71 of 2015 providing a new rate structure for all water customers of the City of Benton which went into effect January 1, 2016; and

WHEREAS, it has been determined that Ordinance 71 of 2015 contained a scrivener's error and misstated the base rate for all residential customers under 65 and not on Social Security as being \$11.35 for the first two thousand (2,000) gallons when the base rate the city has been charging was \$11.75 pursuant to Ordinance 3 of 2009; and

WHEREAS, the Public Utility Commission (PUC) has requested that the City Council amend Ordinance 71 of 2015 in order to correct the scrivener's error and correctly state the base rate.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BENTON, ARKANSAS:

SECTION 1: For the reasons stated above, Ordinance 71 of 2015, Section 1 is hereby amended to state the residential base rate for all residential customers who are under age 65 and not on Social Security shall be \$11.75 for the first two thousand (2,000) gallons of water for a 5/8" and a  $\frac{3}{4}$ " meter.

SECTION 2: In order to correctly state the water rates of the City, it is deemed that this ordinance is necessary to preserve the public health, safety and welfare. An emergency is therefore declared and this ordinance shall be of full force and effect from and after its passage and approval.
