- 1. Review agenda The agenda was reviewed with no changes.

  - a. Official Map: Julia reported that the topic of the Official Map will be discussed at the February Council Work Session on February 5th.
  - b. Sustainable landscaping: Bob reported that he has enlisted a resident Matt Chandler to help on the working group along with Bob and Glenn. Katherine also volunteered to join the working group.
  - c. Investigate creation of a Newtown Borough Climate Action Plan: Tim has scheduled a zoom meeting with Randy Robinson and Peter Buck from the Sustainability Institute at Penn State and will report back.
  - d. Storm Sewer Decals: Additional decals and materials have been purchased and the project will resume in the spring. Pat offered to help with the installation.
