Planning board: 1 Wedgewood Drive; Application Hearing for Tree Removal.

Sept 25. .2025 Wedgewood plan

17 Trees to be removed, plan shows 22 to be installed, states 36, reality should be closer to 50. CT has sent contradictions to engineers, more can follow.

- Everett Park: Requested updates plans fro number removed, number to be replanted, species to be used. The engineering firm has already received some suggestions from the STC chair. We can make others.
- Linden Ave Project- no updates, Questions sent to admin: :Are there any updates regarding the project? Has the number of trees to be removed changed?Can they

accommodate bumpouts for roots? Which entity will be responsible for replanting?

- Verona Streetscape meeting, Sept 12: attendees, plans, input to be discussed.
 We need a date to invite the engineering team to meet with us
 - A Community Forestry Management Plan contractor has been chosen.

 Gracie and Harrigan Consulting Foresters, \$5000

 They will also conduct a thorough inventory of street trees, \$14000

 A Green Communities Grant from NJDEP application has been prepared by

 Millenium Strategies with input from the Shade Tree Commission chair, town admin, DPW. The grant would cover the \$19,000.
- Regional Greenhouse Gas Initiative Natural Climate Solutions Grant

 We will be preparing a three year project plan to apply for a grant of \$300,000 to \$400,000. This will include approximately 300 street trees, site preparation, maintenance equipment, consultant fees, etc.

- Grove Park: dangerous trees to be removed
- Set a date to invite Verona Environmental Commission and Sustainable Verona to a meeting
- No final plan for Lakeside Ave Parking lot available yet
