# REPRESENTATIVE UPDATES

<u>Library update</u> - Plans are underway for Hispanic Heritage Month and Fall-O-Ween.

<u>Schools update</u> - No update at this time.

<u>Recreation</u> – Part-time special needs coordinator role has been filled. Fall dance programs will be re-instated after a brief decision to cut them. There is now a revised traffic flow pattern at the Verona Community Center near the accessible playground. The search continues for the Director of Community Services position.

<u>Town update</u> - C.McGrath attended a forum to discuss age-friendly communities. The Township has secured a \$70K grant to work with NJ Future to develop a survey which will result in a set of recommendations to make improvements to the Township. MIAAC has been invited to have two members be a part of the Township group that will oversee the survey and recommendations. C.McGrath shared that as a result of the Community Block Grant, the Township will update the Verona Community Center doors to be accessible. C.McGrath gave an update on Everett Field and stated the ADA playground is being planned with cost covered by a grant. Field and playground plans are on the Township's website. The Township received a \$250K grant which is to be used to promote an inclusive healthy community.

### **NEW BUSINESS**

Disability Pride Month - MIAAC and the Township offered a free public webinar about inclusive hiring practices. Barbara Stockton, NJ Department of Labor and Workforce Development, led the webinar. Thank you to Michelle O'Neill for organizing the webinar.

Hispanic Heritage Month - MIAAC will join the Library's event, a Puerto Rican dance performance, and offer food and children's crafts. The event is set for Saturday, October 4 at 3pm at the Library.

Fall-O-Ween – MIAAC will have a table for the first time at the Library's Fall-O-Ween event which draws a large crowd every year. MIAAC's table will feature teal pumpkins and offer non-food treats as an inclusive practice for children with food allergies. Also for the first time, the Library will offer a special first hour of the bounce house as a sensory friendly experience.

Diwali - Sub-committee is meeting to discuss plans. Date TBA.

Hannukah - Sub-committee is meeting to discuss plans. Date TBA.

Fair in the Square - Event is set for Saturday, December 6. MIAAC will volunteer in the sensory friendly space in the Library for the Photo Sessions with Santa.
