RESOLUTION No. 2026-094

A motion was made by Councilwoman McGrath; seconded by Councilwoman Holland that the following resolution be adopted:

AUTHORIZING A CONTRACT WITH GABRIELE CONSTRUCTION

WHEREAS, concrete repairs to the DPW garage and replacement of the steps in front of Town Hall are needed due to water and ice damage; and

WHEREAS, the Township of Verona has a need to acquire such services pursuant to *N.J.S.A. 19-44A-20.5*; and

WHEREAS, the Qualified Purchasing Agent has determined that the value of said services will exceed \$17,500.00; and

WHEREAS, this expenditure shall be charged to Budget Account No. C-53-46-040-045 in the amount of \$33,000 and Budget Account No. C-53-46-040-53 for \$7,300, or any other account that may be deemed appropriate by the Chief Financial Officer or her designee, and the availability of funds; and

WHEREAS, the Township Manager has recommended that Gabriele Construction, 53 King Street, Belleville, NJ be awarded a contract to repair concrete at the DPW garage and replace the front steps of Town Hall.

THEREFORE, BE IT RESOLVED by the Township Council of the Township of Verona, in the County of Essex, New Jersey that Gabriele Construction is hereby awarded a contract for providing services not to exceed \$40,300 without further authorization of the Governing Body.

BE IT FURTHER RESOLVED that the Township Manager and the Municipal Clerk are hereby authorized to enter into an agreement for the aforementioned services a copy of which shall be available for public inspection in the Office of the Municipal Clerk.




