**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF ENNIS, TEXAS, CANVASSING AND DECLARING THE RESULTS OF THE JANUARY 31, 2026 SPECIAL ELECTION HELD FOR THE PURPOSE OF ELECTING A MAYOR PRO TEM TO SERVE A TERM EXPIRING MAY 2026 AND A MAYOR TO SERVE A TERM EXPIRING MAY 2027, AND PROVIDING AN EFFECTIVE DATE.**

**BE IT REMEMBERED THAT** on this 9th day of February, 2026, at a meeting of the City Commission of the City of Ennis, Texas, a quorum to canvass being present, the meeting was called to order and the following business was transacted:

**CANVASS OF RETURNS AND DECLARATION OF RESULTS**

**WHEREAS**, the City Commission of the City of Ennis, Texas, ordered a Special Election to be held in the City on January 31, 2026, for the purpose of electing a Mayor Pro Tem to serve a term expiring May 2026 and a Mayor to serve a term expiring May 2027; and

**WHEREAS**, the Presiding Judges and other officials holding the election for a Mayor Pro Tem and a Mayor have submitted the official results to the City Commission as follows, and as shown in "EXHIBIT A", and said returns being made according to law, and duly authenticated, and it being shown that written notice of said election was posted for the time and in the manner provided by law, and all other proceedings pertaining to said elections having been shown to have been done and performed at and within the manner provided by law, and all papers pertaining thereto having been returned and filed with the City Commission and no protest or objection being made to or regarding any matter pertaining to said election; and

That the tabulation of votes cast for the office of Mayor Pro Tem are as follows:

It appearing that no candidate received a majority of the votes required to be declared to be elected, a run-off election will be ordered. The two candidates receiving the highest votes are **Chad Wester** and **David Espedal**.

It appearing that **Lynda Isbell** received a majority of all votes cast for all the candidates for the office of Mayor, and is hereby declared to be elected to the office to serve a term expiring May 2027.

**SECTION 1.** That all of the findings contained in the preamble of this Resolution are found to be true and are adopted as findings of fact.

**SECTION 2.** That upon a motion by \_\_\_\_\_, and a second by \_\_\_\_\_, it was unanimously ordered that the City Commission consider the official returns of the elections held in the City on the above-mentioned date for the election of City Officers.

**IT IS FURTHER ORDERED** that this canvass and declaration of results of said election be entered in the Minutes of the City Commission, and that said Officers, after they have qualified and taken their Oaths of Office, shall serve their respective terms commencing February 9, 2026, and thereafter until their successors are duly elected and qualified.

This Resolution, declaring the results of the election, shall become effective immediately after its passage.

### BACKGROUND INFORMATION:

Texas Election Code provides that if no candidate for a particular office receives the votes necessary to be elected in an election requiring a majority vote, a runoff election for that office is required. The City Commission has canvassed the returns of the January 31, 2026 Special Election and determined that no candidate for the office of Mayor Pro Tem received the votes necessary to be elected by a majority vote.

The two candidates receiving the highest number of votes for the office of Mayor Pro Tem are David Espedal and Chad Wester.

Approval of this resolution orders a Runoff Election to be held on March 14, 2026. Early Voting will be conducted March 5 - 10, 2026.

### FINANCIAL IMPACT:

The City will contract with Ellis County for Election Services at a cost unknown at this time.

**RESOLUTION NO.**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF ENNIS, TEXAS, ORDERING AND PROVIDING NOTICE OF A SPECIAL RUNOFF ELECTION TO BE HELD ON THE 14TH DAY OF MARCH, 2026, FOR THE PURPOSE OF ELECTING A MAYOR PRO TEM FOR A TERM EXPIRING MAY 2026, AND A MAYOR FOR A TERM EXPIRING MAY 2027; PROVIDING FOR EARLY VOTING BY PERSONAL APPEARANCE; PROVIDING FOR POLLING LOCATIONS; AND AUTHORIZING A CONTRACT WITH ELLIS COUNTY ELECTIONS FOR ELECTION SERVICES.**

**WHEREAS,** The City of Ennis, Texas ("City") acting under the authority provided by its charter, adopted by the electorate, pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Local Government Code; and

**WHEREAS,** The City of Ennis Home Rule Charter provides that the city elections shall be held in accordance with the laws of the State of Texas; and

**WHEREAS,** on October 15, 2025, Mayor Pro Tem Lynda Isbell submitted her resignation to the City Secretary's office, resulting a vacancy for the remainder of her term expiring May of 2026; and

**WHEREAS,** the Texas Constitution Article XI, Section 11 provides that vacancies in cities with terms of office greater than 2 years must be filled by a majority vote of qualified voters in a special election within 120 days after the vacancy occurs; and

**WHEREAS,** on October 21, 2025, the City Commission passed Resolution No. 25-1021-F1 ordering a special election for the purpose of electing a mayor pro tem; and

**WHEREAS,** the special election was held on January 31, 2026; and

**WHEREAS,** on February 9, 2026, the City Commission of the City of Ennis, Texas, canvassed the returns of the January 31, 2026, Special Election and determined that no candidate for the office of Mayor Pro Tem, and no candidate for the office of Mayor received the votes necessary to be elected by a majority vote; and

**WHEREAS,** the two candidates receiving the highest number of votes for the office of Mayor Pro Tem are David Espedal and Chad Wester; and

**WHEREAS**, a runoff election must be held to fill the position of mayor pro tem; and

**WHEREAS**, the Texas Secretary of State has approved March 14, 2026, as the date for holding a runoff election; and

**WHEREAS**, Ellis County will be holding Joint Republican and Democrat primary election on March 3, 2026, and Ellis County's early voting dates for the primary elections are from February 17 to February 27, 2026; and

**WHEREAS**, the Ellis County elections administrator has notified the City that her office is unable to mobilize election equipment and staff necessary to hold any early voting dates for the runoff election between February 25 and March 4, 2026, due to the office administering primary elections on March 3, 2026; and

**WHEREAS**, the Ellis County elections administrator has notified the City that the earliest possible date that her office could mobilize for early voting is March 5, 2026; and

**WHEREAS**, due to impossibility and impracticability of Ellis County being able to concurrently conduct early voting dates for both the primary elections and the run off elections, the City will begin early voting dates on March 5, 2026, pursuant to Texas Election Code 85.001(d).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF ENNIS, TX:**

**SECTION 1:** The City Commission finds that the recitals set forth above are true and correct and are incorporated into this Resolution as if written herein.

**SECTION 2: RUNOFF ELECTION ORDERED** - That the City Commission does hereby order a runoff election to be held on March 14, 2026, under the authority of the Home Rule Charter of the City of Ennis, Texas, and the laws of the State of Texas, for the purpose of electing a Mayor Pro Tem to serve the remainder of a three-year term expiring May 2026.

**SECTION 3: JOINT ELECTION AGREEMENT** - The Mayor and the City Secretary are authorized to enter into an election agreement and contract for election services with Ellis County under the authority of Chapter 271 of the Texas Election Code. The election shall be conducted pursuant to the election laws of the State of Texas.

**SECTION 4: EARLY VOTING CLERK** - Jana Onyon, Ellis County Elections Administrator, 204 E. Jefferson Street, Waxahachie, Texas 75165, is hereby appointed as Early Voting Clerk and General Custodian of the Election Materials and Records until the time period required by law has lapsed. Applications for early voting ballot by mail should be mailed to the Early Voting Clerk at the above address; or faxed to 972-923-5194 and mailed within 4 days; or email a signed copy of the application to Elections@co.ellis.tx.us. The deadline for submitting applications for voting by mail is March 3, 2026.

**SECTION 5: EARLY VOTING** - Early voting by personal appearance shall be conducted as listed below and as provided in the attached Notice of Election (EXHIBIT A):

Thursday, March 5, 2026 - Saturday, March 7, 2026 from 8:00 A.M. thru 5:00 P.M.

Monday, March 9, 2026 and Tuesday March 10, 2026 from 8:00 A.M. thru 5:00 P.M.

**SECTION 6: ELECTION DAY VOTING** - Voting on Election Day, March 14, 2026, shall be conducted between the hours of 7:00 A.M. and 7:00 P.M. at the following locations and as provided in the attached Notice of Election (EXHIBIT A):

Ellis County Sub-Courthouse (Conf Room), 207 S. Sonoma Trail, Ennis, TX 75119

City of Ennis Public Library (Learning Center), 501 W. Ennis Avenue, Ennis, TX 75119

**SECTION 7: ELECTION RESULTS** - The results of the election shall be certified, canvassed, and returned in the form and manner prescribed by the laws of the State of Texas and the Charter and ordinances of the City of Ennis.

**SECTION 8: NOTICE OF ELECTION** - The notice of election hereby ordered and called shall be promulgated, published and posted in keeping with the laws of the State of Texas and the Charter and ordinances of the City of Ennis.

**SECTION 9: VOTER REGISTRATION DEADLINE** - The voter registration deadline for the March 14, 2026 Runoff Election is February 12, 2026.
